## ORDER

Sanction is hereby accorded for Rs. 100 crore to cover about 1.63 lakh beneficiaries for providing financial assistance of Rs. 6000/- to eligible family per annum under Mukhya Mantri Parivar Samridhi Yojna (MMPSY). The list of beneficiaries - district wise is enclosed herewith. The expenditure will be incurred under Major Head "2075-51-800-88-51-89 Misc".

The amount will be utilized as under:-

- (a) To defray the premium payable under the Pradhan Mantri Jeevan Jyoti Beema Yojna (PMJJBY) @ Rs. 330 per annum per family member in the age group 18-50 years.
- (b) To defray the premium payable under the Pradhan Mantri Surksha Bima Yojna (PMSBY) @ Rs. 12 per annum per family member in the age group of 18-70 years.
- (c) To defray the premium payable under the Pradhan Mantri Fasal Beema Yojna (PMFBY), if applicable.

Further, an amount in the range of Rs. 55-200 per month will be paid on behalf of eligible family members in the age group of 18-40 years under three pension schemes namely:-

- I. Pradhan Mantri Shram Yogi Maan Dhan Yojna (PMSYMY).
- II. Pradhan Mantri Laghu Vypari Maan Dhan Yojna (PMLVMY).
- III. Pradhan Mantri Kissan Maan Dhan Yojna (PMKMY)

The sanction is subject to the condition that the beneficiaries will fulfill the eligibility conditions, fill up the MMPSY consent forms and submit to the concerned Treasury Officer at District level. The Treasury Officer after scrutinizing the consent forms will transfer the funds in the beneficiaries account. The concerned banks will pay the amounts in the above mentioned insurance and pension schemes as per norms of these schemes. The balance amount, if any, after deducting the consolidated amount of premium/contribution for all the above-mentioned social security schemes will be disbursed in cash to the bank account of the Head of the family or deposited in the Family Provident Fund as opted by the Head of the family.
