Part-II examination are offered appointment on purely stop-gap-arrangement in the SAS cadre against the post of Section Officer in their own pay scale as Supdt/Asstt/Sr. scale stenographer/steno-typist/clerk etc. which they are drawing basic pay + Rs. 100/ special Pay for the performance of duty as Section Officer against vacant post on the following terms and conditions :-

1. It is a purely a stop-gap-arrangement and officials offered appointment will have no right to the post of Section Officer (OB)
2. They can be reverted back to their parent department on or prior to the availability of SAS qualified person or on any other administrative grounds.
3. They will not have any right /claim of regular/permanent appointment as SAS Section Officer and the pay scale and other benefit attached to the post.
4. In the matter of disciplinary action they will be strictly under the control of their parent Department. However Director, Treasuries and Accounts Department will have the right to recommend for initiating disciplinary proceedings.
5. In some cases i.e. from Sr. No. 1 to 9, these orders will supersede the orders issued by this department vide No. TA-HR(4T)2012/5993-6098 dated 2.5.2012.
6. The appointment will not confer any right to the post of section officer towards pay, experience, seniority and probation etc.


