Reference: Memo No. TA-HR(DMC)/2019/689 Dated 10.05.2019

Please refer to the Finance Department's instruction dated 10.01.2018 and subsequent orders issued thereafter on the above mentioned subject. Vide these instructions it was desired that the amount of Pension/Family Pension should be verified by SAS personnel of the concerned Department before sending it to Principal Accountant General (A&E) office.

Vide above referred order SAS personnel were deputed in each district to verify the revised pension cases of Elementary & Secondary Education and Health Department. However, during the Video Conferencing with Pensioner's Association held on 03.12.2019. It came to notice of the Higher Authorities that in spite of these order Pension Cases are pending with all DDOs in the State of Haryana.

Hence, in order to monitor the work related to verification of pension cases, a team of Senior Officer of SAS Cadre is hereby constituted district wise (Annexure 'A'). The team will monitor the work of pending cases of Pension Revision of all departments/offices in their respective districts. These monitoring teams will submit report on fortnightly basis (district wise) to the Nodal Officer, ODAS, Treasuries & Accounts Department. Haryana.

It is pertinent mention here that all Treasury Officers will ensure from their respective DDOs in the district that there may not be any pending pension case as on 31/01/2020. However for Ambala District deadline will be 31.12.2019. The Noncompliance of above instructions will be viewed seriously.
