After being qualified SAS (Part-II) exam, the following candidate are hereby appointed in SAS Cadre as Section Officers against Vacancy in FLP-7 (Rs. 44900/- initial) Plus Rs 100/- special pay as per HCS (RP) Rules, 2016 on temporary basis on the following terms and conditions :-

1. They will be governed by Haryana State Accounts Subordinate (Group C) Service Rules, 2013.
2. This appointment will be effective from 28th May, 2020 (notionally) from the date of appointment of Sh. Ramesh Chander, Section Officer and actual from the date (s) of joining.
3. The above appointment is subject to pending ACRs , if anything adverse regarding integrity is noticed in the pending ACRs he/she will be reverted back to his/her parent Deptt.
4. This appointment is also subject to pending disciplinary proceeding in their parent department or where they are working under stop gap arrangement and on being found guilty, will be reverted back to their parent Department.
5. They will be on probation for a period of one year to be extended for further one year.
