Sir/Madam,

I am directed to invite your attention to this department's notification No. 2/51/2008-1Pension dated **04.10.2013** (copy enclosed) issued under endst No. 2/51/2008-1Pension dated **24.10.2013** wherein an explanation was added regarding recovery of additional share of commuted value of pension in Rules-

15 after clause (C) of Haryana Civil Services (Revised Pension) Part-II, Rules 2009 in the following matter:-

"If a person becomes entitled to additional amount of commutation due to any reason, after the release of original commutation, the recovery on account of such additional commutation would be effected from the date from which original recovery was started."

- 3. The said explanation is quite clear for recovery of additional share of commuted value of pension but it has been brought to the notice of State Government that your banks have not been following the above rule/procedure for effecting the recovery of additional share of commuted value of pension, which is a serious matter.
- 4. Hence, it is requested to ensure the recovery of additional share of commuted value of pension as per provisions contained in the notification dated **04.10.2013** so that full & final recovery of commutation value of pension can be made on time schedule as per rules.
- 5. Further, it is also requested **to review all the cases** of additional share of commuted value of pension and revised accordingly.

- 1. (1) ये नियम हरियाणा सिविल सेवाएं (पुनरीक्षित पेंशन ) भाग II संशोधन नियम, 2013, कहे जा सकते हैं।
  - (2) ये नियम जनवरी, 2008 के प्रथम दिन से लागू हुये समझे जायेंगें।
- 2. हरियाणा सिविल सेवाएं (पुनरीक्षित पेंशन ) भाग II नियम, 2009 में नियम 15 में खण्ड (ग) के बाद अन्त में, निम्नलिखित व्याख्या जोड़ दी जाएगी, अर्थात:—
- "व्याख्या:— यदि कोई व्यक्ति मूल-संराशिकरण की राशि के जारी करने के बाद, किसी भी कारण से, अतिरिक्त संराशिकरण की राशि का हकदार बनता है, तो ऐसी अतिरिक्त संराशिकरण के मद्धे वसूली ऐसी तिथि से प्रभावी होगी जिससे मूल वसूली प्रारम्भ की गई थी।"
