The Bank account will be a saving account operated singly by the account holder, however it would not be allowed to be operated upon by another person by virtue of a power of attorney executed in his favour. Such account should not be a Joint account with either or survivor except for the case that in case of pension such Joint account can be opened by the pensioner with his/her spouse in whose

favour an authorization for family pension exists in the Pension Payment Order(PPO). The Joint account of the pensioner will be operated subject to the terms and conditions as per Finance Department Haryana letter No. 5/50/05-3 Pension dated 30-12-2005/02-01-2006. A certificate to this regard, as per Annexure E-I(copy enclosed) from the bank branch will be required to be submitted by the pensioner to the Treasury Officer at the time of presenting his pension claim for the first time.
