Kindly refer to the Finance Department's instructions No. 28/14/2016-5B&C dated 28.6.2016 on the subject noted above.

- 2. Haryana Government has decided to implement Human Resources Management System (HRMS), under which the personal information of each employee like Service Book, ACR, promotion details, leave details, transfer etc are to be maintained. In this regard Standard Operating Procedure (SOP) was sent to all Departments vide this office letter No. TA-HR(DMC)/2016/7130 dated 8.7.2016 indicating interalia, time schedule of implementation. The HRMS system is to be implemented in four phases, vis, Phase I Creation of Master Data, Phase II Updated from e-salary, Phase III Finalised Record of employees and Phase IV Enter Historical Data of employees. All these phases were to be completed by 30.10.2016.
- 3. Digital Cell in CM Office is monitoring the implementation of HRMS and it has set the following time lines for it:
 - (a) Phase IV for all Departments to be completed by 30.6.2017.
- 4. Your Department has completed the Phase-I to Phase-III despite best efforts of the Finance Department in this regard.
- 5. You are, therefore, requested to adhere to the timelines indicated by Digital Cell of CM Office to complete the implementation of HRMS, otherwise Finance Department is forced to stop all payments of your Department through Treasuries after 30.06.2017. It is further informed that Hon'ble Chief Minister Haryana will review the implementation of HRMS shortly.
