Regarding recovery of House Building Advance and Motor Car Advance from the Ex-Members of Haryana Vidhan Sabha.

Sir,

I am directed to state that House Building Advance and Motor Car Advance recoverable in 100 monthly installments are sanctioned to the Hon'ble Members of the Haryana Vidhan Sabha under the provision of the Haryana Legislative Assembly (Facilities to Members) Act, 1979 and Rules framed there under. Recoveries are made from their Salaries/Allowances of the sitting Members. However, on ceasing as Member, the recovery of the said advances are made from their pension/family pension from their respective Treasury through Treasury Officer.

This Secretariat is already facing difficulty in making the recoveries of their loan from the Ex-Members who have got their pension accounts transferred in the Banks. Most of the Banks from where the Ex-MLAs are drawing their pension/family pension do not make recovery of House Building Advance and Motor Car Advance from the pension of the concerned Ex-Members. Rule 9(5) and Rule 23(5) of the Rules ibid regarding recovery of House Building Advance and Motor Car Advance provide as under:-

Rule 9(5)	Rule 23(5)
"In case, the borrowers ceases to be a member before the advance and interest thereon are fully repaid, the outstanding balance together with the interest thereon shall continue to be recovered at the rate hitherto fore from the (pension/family pension and dearness allowance) which has become due to the borrower unless he has voluntarily made payment of the remaining installments in lump sum or otherwise. In case there is any deficiency or shortfall in recovering the amount of the advance, the borrowers shall be required to make payment through his own sources. In case where he does not comply with the conditions of the repayment the provision of the mortgage deed shall be invoked immediately."	"In case, the borrowers ceases to be a member before the advance and interest thereon are fully repaid, recovery shall continue to be made at the rate heitherto fore from the (pension/family pension and dearness allowances) which has become due to the borrower or from any of his other assets unless has voluntarily made payment of the remainining instalments in lump sum or otherwise. In case there is any deficiency or shortfall in recovering the amont of advance, the borrower shall be required to make the balance payment through his own resources. In case, where he does not comply with the conditions of the repayment the provisions of the mortgage deed shall be invoked immediately."

If PPO's of all the Ex-Members will be transferred in other Banks, then it would be quite difficult to recover the Loan amount from Ex-Members. It is also stated that interest on MCA and HBA is calculated only after receiving complete treasury vouchers regarding recovery of the principal amount from the concerned treasuries. Banks do not supply any information regarding such recoveries from the

pension/family pension. In case PPO's of MLAs are transferred in banks then it will not be possible for this Secretariat to calculate the interest in absence of detail of recoveries and it will cause difficulty to the Hon'ble Ex-Members as their MCA/HBA case will not be settled in time.

In view of the above facts and circumstances, it is requested that all the Treasury Officers and Assistant Treasury Officers in the State of Haryana may be directed not to transfer the PPO's of the Ex-Members and the PPOs which have already been transferred to bank, be withdrawn and returned in the treasuries itself.
