In this regard, it is submitted that as State Government has implemented Jeevan Pramaan Portal in Treasuries/Sub Treasuries for the pensioners of State Govt. It has been decided to further extend the above facility of Jeevan Pramaan Portal in banks for Haryana Government Pensioners.


The amendment to this effect has been carried out under Rule 4.106 of the subsidiary Treasuries Rules, regarding submission of Life Certificate by the Haryana Government Pensioners which is reproduced below:

“A Life certificate issued online by Government Agency as a result of Aadhar Biometric Authentication will also be accepted as a valid certificate. This

document may be accessed through a website (www.jeevanpramaan.gov.in) by the Treasury/Sub-Treasury without insisting either on personal appearance of the pensioner or life certificate by the competent authority referred above."

Therefore, you are requested to do the needful for successful implementation of Jeevan Pramaan Portal for Haryana Govt. Pensioners in all your bank branches at the earliest.

In exercise of the powers conferred by the provision to article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Haryana hereby makes the following Rules, further to amend the Punjab Treasury Rules and Subsidiary Treasury Rules, (Volume I) as applicable in State of Haryana namely:-

1. These Rules may be called the Punjab Treasury Rules and Subsidiary Treasury (Amendment) Rules, (Volume I) 2015
2. In the said Rules in Rule 4.106 (1), Rule 4.106 (1A) Shall be added as under:-

"A life certificate issued online by Government Agency as a result of Aadhar Biometric Authentication will also be accepted as a valid certificate. This document may be accessed through a website (www.jeevanpramaan.gov.in) by the Treasury/Sub-Treasury without insisting either on personal appearance of the pensioner or life certificate by the competent authority referred above."

संख्या-14/10/2013-5वि0ले0 भारत के सविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, पंजाब खजाना नियम तथा अनुपूरक खजाना नियम (वाल्यूम-1), हरियाणा राज्यार्थ को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात:-

1. ये नियम पंजाब खजाना नियम तथा अनुपूरक खजाना (हरियाणा संशोधन) नियम (वाल्यूम 1), 2015 कहे जा सकते हैं।
2. पंजाब खजाना नियम तथा अनुपूरक खजाना नियम (वाल्यूम 1), में नियम 4.106 में उप-नियम (1) के बाद, निम्नलिखित उप-नियम रखा जाएगा, अर्थात:-

“(1क) आधार जीवमिति प्रमाणिकरण के परिणामस्वरूप सरकारी एजेंसी द्वारा जारी किया गया जीवन प्रमाण-पत्र वैध प्रमाण-पत्र के रूप में भी स्वीकार किया जाएगा। यह दस्तावेज या तो पेंशनर की व्यक्तिगत उपस्थिति पर या उपरोक्त निर्दिष्ट सक्षम प्राधिकारी द्वारा जीवन प्रमाण-पत्र आग्रह किए बिना खजाना/उप-खजाना द्वारा वेबसाइट (www.jeevanpramaan.gov.in) के माध्यम से सुलभ हो सकता है।”
