I have been directed to your office letter no. TA-HR(PDC)/2018/1140 dated 25.10.2018 on the subject noted above and to say that vide this officer letter No. BF 30/77-CAG/7955 dated 20.11.2018, the case was sent to the Govt. for clarification whether the benefit of fixed medical allowance is applicable to the Ex-Chairman/Members or not?

Therefore, you are requested to direct all the concerned Treasury Officers to grant the benefit of fixed medical allowance to the Ex-Chairman/Ex-Members, HPSC with their pension as per notification dated 13.03.2018.
