**Subject:** Top five projects/ schemes/ programmes to be launched/ implemented for the period Nov. 2015 to Nov. 2016--- shifting of PPOs from banks to treasury/ sub treasury/ PDC and review thereof.

Please refer to the subject cited above.

With reference to the department letter no. TA-HR(DMC)/2015/6053 dated 03.11.2015 vide which target of shifting of more than 1.50 lakh PPOs was fixed up to 10/2016 and subsequent letter Nos. TA-HR(PDC)/2016/383 dated 14/01/2016, TA-HR(PDC)/2016/463 dated 16/3/2016, D.O. No. PDC/604 dated 24/05/2016 and TA-HR(PDC)/2016/707 dated 15/07/2016 on the subject cited above.

In this regard, the latest status of shifting of PPOs from Bank branches to treasuries/sub treasuries/ PDC is enclosed herewith. This status was reviewed by Worthy Director General Treasury and Accounts Department on 10-08-2016 and observed that the process of receiving of PPOs in the e-pension system from bank branches is very slow and the same needs to be speed up forth with.

In view of the position mentioned above, you are, therefore, once again requested to personally take up the matter to speed up the above process of receiving the PPOs in the e-pension system sent by the banks to treasuries/ Sub treasuries and to contact the bank branches to start shifting the PPOs which have not started yet in view of target set by the Govt. upto 31/10/2016 in view of Golden Jubilee Celebration Year in Nov, 2016.

The NIC has observed that some of the sub treasuries are forwarding the query regarding e-pension system directly to the NIC which can be easily solved at District Treasury/ PDC level. In this regard the Treasury Officers are requested to again impart the training to all the Data Entry Operators/ Pension Dealing Officials in all their respective sub treasuries. So that the officials at the sub treasury level may receive the PPOs in the e-pension system speedily and effectively. You are also requested to resolve the query regarding e-pension system pointed out by sub treasuries under your jurisdiction. However, the query if not resolved by the Treasury Officer, the same may be forwarded to PDC. Then PDC will resolve it and if not resolved by PDC, the same will be forwarded to NIC. The solution will be forwarded to you after it is resolved/ solved by the NIC.
