Dear Treasury officer/ Asstt. Treasury officer,

I would like to draw your kind attention to department letter no. TA-HR(DMC)/2015/6053 dated 03.11.2015 vide which target of shifting of more than 1.50 lacs PPOs was fixed up to 11/2016 and subsequent letter Nos. and E-mails mentioned in the margin, on the subject cited above.

As you are aware that for shifting of PPOs userid-passwords of banks have since been issued by NIC as mentioned in the Annexure-I. The bank wise status-report regarding shifting of PPOs is also mentioned in the Annexure-I. The receipt of PPOs by the Treasury officers/ Assistant Treasury Officers is at Annexure-II which are self-explanatory. A perusal of the reports of the shifted/ received PPOs by the different banks and received by Treasury officer/ Assistant Treasury officer shows a very slow speed. It is also strange that many of the bank branches have yet not started the process of shifting of PPOs. This is worthwhile to mention that with this slow speed of shifting of PPOs by the banks and receipt thereof, the above target set by the govt. up 11/2016 might not be achieved.

Therefore, I would like to request you again to speed up the process to receive the PPOs sent by bank and pursue the matter with Banks concerned to speed up/start the above process of shifting of PPOs to treasuries/sub treasuries as this project has been included in one of the top five projects in view of Golden Jubilee Celebration Year by the Govt. so that the above target may be achieved up to 11/2016.

TOP PRIORITY in the above matter will be appreciated.

The employees who were earlier drawing pension from treasury or who have retired on or after 1.10.2012 are getting their pension through this system. The beauty of this system is that now all the pensioners in Haryana who retired after 1/10/2012 getting their pension and credited in their accounts through Centralized Pension Disbursement Cell on 1st of every month. Now it has been decided to shift about 1.50 lacs pensioners who are getting their pension from banks to E-Pension system under Pension Disbursement Cell (PDC). This activity is under process and will be completed from Nov, 2015 to Nov, 2016 (Golden Jubilee Year). |
