CORRIGENDUM

Reference is made to E.O.I. Notice No.: TA-HR(DMC)/EOI/ 2012/2531 DATED 07.09.2012. Following corrections/alterations in EOI are made:

(i) The eligibility criteria for the banks offering their services under the "Treasury Receipts and Payments" in Section-5, Page 10 under subheading "Eligibility Criteria" Clause 'V', may be read as:

"The bank can make offer for treasury business at a place where it is having a bank branch within a distance of 2 Km from the treasury or if it is ready to open a bank branch within such distance within a period of 90 days from the date when acceptance of offer is conveyed to it by the Government. Further a bank which does not have a branch and offers to open one within a period of 90 days from the date of acceptance will be required to provide a bank guarantee with a validity of six months to the department @ Rs. 2,00,000/-(Rs. Two lakhs only) per such branch. Such bank guarantee will be provided within a period of fifteen days of communication of acceptance by Government. If the bank fails to open such a bank branch within the said period of 90 days, the bank guarantee shall be forfeited. Government may at its discretion allow extension upto a maximum period of 30 days for opening of such branch, however forfeiture of bank guarantee will be done irrespective of such extension, if the branch is not opened within specified time period of 90 days."

- (ii) On page 17 in Form 'D' Sr. No. 2 under column "Reference Details" following lines stands deleted "Also provide the volume and value of transactions handled by the bank for the last two quarters for NEFT//RTGS/ECS."
- (iii) On page 18 in Form 'E' Sr. No. 7 is inserted after Sr. No. 6 with the following contents:
