Subject: Instructions regarding re-appropriation of fund request and submitting of bills in Treasury in month of March, 2021.

In continuation of the instructions issued vide No. 28/14/2011-5B&C dated 05 December, 2012, 16th January, 2013, 10 January, 2014, 24th March 2015, 09th February 2016, 22nd March 2016, 22nd February 2017, 01 March 2018, 12 February 2019 and 10 February 2020, the Government has further decided to improve upon the procedure and to reduce unproductive expenditure/curb parking of funds to avoid rush of expenditure toward fag end of financial year as follows:-

"No bills including Works Bill, except Salary, Wages, Discretionary Grants, Petty Grants, Medical Reimbursement, GPF Advance/ Withdrawal & Centrally Sponsored Scheme will be passed by treasury after 01.03.2021".
