Non collection of demand drafts/banker cheques by departments and submission of bills by unauthorized Persons.

Please refer to the subject cited above.

- 2. It has been brought to the notice of this Department that many Demand Drafts and Banker cheques are pending in different branches of different Agency Banks (Treasury Banks) since long which have not been collected by concerned DDOs of different Department on time. Such drafts/cheques have been generated by concerned bank branches on account of DDO BT as shown in Electronic Pay Order (EPS) or failed transactions due to incorrect account number or inoperative account number. Later on such Departments request for revalidation of such instruments which is wastage of stationary and resources. There is also risk of change in name, which may result in fraudulent payment to unauthorised person.
- 3. In addition to the above, it has been mentioned by the Bank that unauthorised persons used to visit bank branches to collect EPS and Financial Instruments (Draft/Cheque) which is a matter of serious concern. As per Rule/Instruction only authorised messenger can deliver/collect EPS and financial instruments from Banks.
- In the light of above facts, you are therefore, requested to direct all DDOs under your control to collect Demand Drafts/Cheques from agency bank branches well on time to avoid any lapse or misappropriation of funds. Further, DDOs may also ensure that only authorised messengers may be send to Treasury Banks to handover/collect EPS and other Financial Instruments. This may be brought to the notice of all concerned.

This may be treated as Most Urgent.
