Sir/Madam,

Kindly refer to this department's memo No. 2/23/2016-1Pension (FD) dated **07.12.2018** wherein it was decided to send the pension revision cases of pre-2016 pensioners **through Online Diary Application.**

To redress the grievances of the pensioners and for speedy finalization of pension case of Government employees. Principal Accountant General (A&E) Haryana Chandigarh has developed the **Online Diary Management System (ODMS)** and fresh pension cases are required to be sent through this module.

Now, after due consideration, it has been decided by the State Government that a pilot may be conducted **in the following districts** for submission of Fresh Pension Cases in Online Dairy Management System (ODMS):-


1. Hisar

You are, therefore, requested to bring the above instructions to the notice of all concerned working under your control for strict compliance.




