Subject: - Uploading employee data of all Boards and Corporation and updation of Parivar Pahchan Patra (PPP) including contractual employee.

I am directed to invite your attention to Chief Secretary, Haryana letter no.62/34/2020-6GS-I dated 20.11.2020 and Finance Department letter no.28/34/2020-5B&C dated 28.07.2020 and others issued from time to time on the above mentioned subject.

2. Vide above referred letters, all the Administrative Secretaries, Managing Directors/Boards/Corporations were requested to direct the Nodal officers concerned of their department as well as all the constituent units under their administrative control to ensure that the data of all the employees is uploaded as well as updated in HRMS positively. However, in spite of several requests it has been found that many Boards/Corporations/PSE etc. have not yet updated their employee data on HRMS portal.

3. Therefore, it has been decided that any grants to such PSE, will be released now onwards after submission of undertaking that all employees data has been uploaded on HRMS and completed in all respects.
