**ORDER**

Whereas, considering Merit No. 566, as conveyed by the Haryana Staff Selection Commission, earlier the seniority as it stood on 01.06.2006 of Sh. Anoop Singh was re-fixed as Clerk on 03.02.2012 from Serial No. 322 to 202-B after obtaining the opinion from the Government. Further, in view of his above re-fixed seniority, he was promoted as Assistant in the Pay Band of Rs. 9300-34800+3200G.P. vide Order bearing Endst. No. 7974 -TA-HR (9T)2012/12770-813 dated 19-10-2012 w.e.f. 29.02.2008 that is the date on which his junior was promoted as Assistant and actual from the date of issue of orders. Thereafter, he was promoted as Assistant Superintendent Treasury in the Pay matrix Level-6 (Pre Revised Pay scale PB-2, 9300-34800+3600 GP) vide Order bearing Endst. No. 6889-TA-HR(9T)2017/SPL-1 dated 07.10.2017.

2. Earlier the seniority, as it stood on 01.06.2006, of Smt. Vimlesh Kumari was fixed as Clerk at Serial No. 208, which has now been changed to 202D(i) considering Merit No. 563 as conveyed by the Haryana Staff Selection Commission vide their office Memo No. 1/66/2018 C-2 dated 14.12.2018. Accordingly, the seniority as it stood on 01.06.2006 of Sh. Anoop Singh has also been re-fixed as Clerk from Serial No. 202-B to 202D(ii). The revised seniority was duly circulated to all the Treasury Officers in Haryana besides a copy to concerned employee vide this office Memo No. 7147-TA-HR(3T)2021/1097-1099 dated 23.02.2021. Resultantly, above name employee Sh. Anoop Singh became junior to Smt. Vimlesh Kumari as Clerk, who was earlier senior to her.

3. In the light of the above re-fixed seniority of Smt. Vimlesh Kumari and Sh. Anoop Singh, Smt. Vimlesh Kumari, Assistant is, hereby, promoted as Assistant Superintendent Treasury in the Pay Matrix Level-6, (35400-112400) on purely temporary basis w.e.f. 07.10.2017 on notional basis, the date when her immediate junior Sh. Anoop Singh was promoted as Assistant Superintendent Treasury and actual from her date of joining as Assistant Superintendent Treasury and posted as such in the office of Treasury Officer, Faridabad.

4. Treasury Officer, Faridabad is directed to re-fix the pay of Smt. Vimlesh Kumari notionally w.e.f. 07.10.2017 and actually from her date of joining as Assistant Superintendent Treasury as mentioned above and thereafter release all consequential benefits after following all due procedure.
