## GOVERNMENT OF HARYANA Treasuries and Accounts Department

## ORDER

Whereas, considering the complaint received through CM Window from Sh. Gurdev Singh Walia, Assistant in the office of Treasury Officer, Jagadhari, wherein he has challenged that the seniority of Sh. Jai Bhagwan, Clerk as stood on 01.06.2006 has been constructed, is considering the date of regularization of the adhoc service of Sh. Jai Bhagwan as 01.04.1993. Whereas the adhoc service of Sh. Jai Bhagwan was regularised w.e.f. 31.03.1993 vide this office Memo No. 16665-TA-HR(3T)-94/164-168 dated 06.01.1994 in terms of provisions contained in the Haryana Government, General Administration Department (General Services-I) Notifications dated 01.06.1993.

Further, in supersession of Haryana Government, Department (General Services-I) Notifications dated Administration 01.06.1993, the Government of Haryana notified vide its Notification dated 11.05.1994 specifies such class-III posts as have been held for a minimum period of two or five years on the 31st March, 1993, by class III employees on adhoc or daily wages basis to be taken out of the purview of the Subordinate Services Selection Board, Haryana to regularise their services fulfilling with certain conditions. The relevant contents of the conditions, as contained in the above referred notification dated 11.05.1994, are as under: -

- (a) That only such adhoc employees, who had completed a minimum of two years service on the 31<sup>st</sup> March, 1993 and were in service on the 31<sup>st</sup> March, 1993, should be made regular.
- (b) That only such daily wagers, who had completed five years service on the 31st March, 1993 and were in service on the 31st March, 1993, should be regularised.

The case was examined at length in the light of provisions contained in the above referred notifications dated 01.06.1993 and 11.05.1994 and observed that the services of both the employee alongwith 27 others employees,

who were working either on adhoc or daily wage in the Department, were regularized as under: -

- (i) Sh. Jai Bhagwan was initially appointed to the post of Clerk on adhoc and he had joined on 03.03.1989 in the office of Treasury Officer, Karnal. The adhoc services of Sh. Jai Bhagwan were regularized as Clerk w.e.f. 31.03.1993 vide Memo No. 16665-TA-HR(3T)-94/164-168 dated 06.01.1994.
- (ii) Sh. Gurdev Singh Walia and 27 others employees were initially appointed to the post of Clerk on Daily Wages in the year 1985 & 1986. Accordingly, all had joined in the office of concerned Treasury Officer/Assistant Treasury Officer in the State. The services of all these 27 employees, including Sh. Gurdev Singh Walia, were regularized as Clerk w.e.f. 01.04.1993 vide Memo No. 24658-TA-HR(3T)-94/12288 dated 25.10.1994.

From the above facts, it is clear that the adhoc services of Sh. Jai Bhagwan were regularized w.e.f. 31.03.1993 whereas the daily wages services of Sh. Gurdev Singh Walia and 27 others employees were regularized w.e.f. 01.04.1993. However, as per Notification dated 01.06.1993 and 11.05.1994, adhoc or daily wages services had to be regularized w.e.f. 01.04.1993 subject to fulfillment of all the conditions laid down in the ibid notifications.

In order to comply with the provisions of above referred notifications, the adhoc services of Sh. Jai Bhagwan, which were earlier regularized w.e.f. 31.03.1993 vide Memo No. 16665-TA-HR(3T)-94/164-168 dated 06.01.1994, is modified to the extent that the adhoc services of Sh. Jai Bhagwan is, hereby, regularised w.e.f. 01.04.1993. However, rest of the conditions, as laid down in the Memo No. 16665-TA-HR(3T)-94/164-168 dated 06.01.1994, shall remain same.
