- 1. Your appointment is purely on temporary basis. Your services are liable to the terminated without assigning any reason by giving one month's notice or pay and allowances in lieu thereof, at any time.
- If at any stage you desire to resign, you will be required to give one month's clear notice or deposit/forfeit in lieu thereof one month's salary including allowances or for the period by which the notice falls short of one month in case of your temporary appointment and in case of your permanent appointment. You will be required to give three months clear notice or deposit/forfeit in lieu thereof your three months salary including allowances for the period by which the notice falls short 3 months, such a notice will also be given to you by the competent authority in case it is proposed to terminate your service except as a result of disciplinary action for any other reasons.
- 3. No TA/DA will be admissible for joining the post.
- 4. Before assuming the charge of duty you will be required to take the prescribed oath of allegiance to the constitution of India.
- 5. No application for employment outside the Department will be considered before you complete 2 Years service in the Department.
- You will have to produce an Affidavit duly attested by the oath commissioner/Magistrate to the effect that you have not more than one living wife, if married.
- 7. You should submit medical fitness Certificate from the concerned Chief Medical Officers within one month of your duty as required under rule of HCS (General) Rules 2016 failing which this appointment shall stands cancelled.
  - 8. You should have to pass State Eligibility Test in Computer Appreciation and Application (SETC) within the probation period as per Haryana Finance Treasuries and Accounts Department State Group 'C' Service (Amendment) Rules, 2013. In case of non-qualifying the SETC during the period of probation 'No Increment and 'No Promotion' shall be admissible as per CS instruction No. 17/02/2021-3GS-II dated 30.03.2021.
  - You have to abide by such rules and Regulation as may be issued by the Haryana Government governing the condition of its employees from time to time.

- You will not undertake higher study of any kind without obtaining the prior permission of the competent authority.
- 11. You are required to submit an affidavit duly attested by the oath Commissioner/Magistrate to the effect that you have not been dismissed from any Government service, if any held by them previously.
- 12. Your appointment to this post in the service is being made on probation for a period of 2 years. If your work and conduct is not found satisfactory, your services can be terminated without assigning any reason. The period of probation can be extended by the competent authority upto one year more.
- 13. Your seniority will be fixed in the cadre of clerk, according to the merit list prepared by the HSSC and not on the basis of your joining on the post.
- 14. Your appointment is subject to the condition that your documents pertaining to their qualification, experience, age and caste/ category shall be got checked/ verified from the issuing authority and if something is found objectionable, you will not be eligible to continue in service.
- 15. You will be governed under National Pension Scheme, 2006.
- 16. The above offer of appointment is further subject to the Haryana Finance Treasuries and Accounts Department State (Group C) Services Rules, 1980 and (Amendment) Rules, 2013 as amended from time to time and other rules and regulations and executive instructions issued or to be issued by the State Government from time to time.
- 17. As the character and antecedents has not been got verified in terms of instructions issued vide Memo. No. 52/8/2022-III GS dated 23 June, 2022 therefore; it is made clear that in case subsequently any adverse facts come to the notice of the State Government regarding their character and antecedents, your services will liable to be terminated without any notice.

If the above terms & conditions are acceptable to you, please report for duty in the office of Director, Treasuries and Accounts Department Haryana, Chandigarh immediately but not later than **15 days** failing which it will be presumed that you will not join the service unless you are able to furnish a satisfactory explanation for not joining the service within stipulated time period.
