CRA system will validate all the details entered by Nodal Office. In case any of the validation fails, CRA system will reject the request. In such cases Nodal Office will have to raise a fresh online request and follow the maker-checker procedure mentioned in earlier slides.

PRAN will be generated on T+1 basis (T being Date of authorization of request by checker). Emails would be sent by CRA to the concerned DTA/DTO and Subscriber on their registered e-mail ID. Subscriber would also receive confirmation through SMS on his/her registered mobile number.
