Subject: -Haryana State Accounts Service Examination (HSAS),Part-I (OB).

1. I am directed to invite a reference to the subject noted above and to inform that Haryana State Accounts Service Examination, Part- I (OB) is likely to be held in the month of July, 2023. The exact schedule and venue for holding HSAS, Part I Examination (OB) will be notified by HIPA, Gurugram in due course.

2. Applications are invited online from amongst regular employees of organizations working on a post Group B or C or equivalent post, possessing a bachelor degree or its equivalent and having rendered minimum three years regular satisfactory service on any of the Group B and/or C post.

“Organization” means and includes all Departments of Haryana Government, statutory Bodies. It also includes Universities, Boards, Corporations, Federations, Authorities wholly owned and controlled by the State Government.”

Exception: - The employees of Constitutional Bodies namely, Haryana Vidhan Sabha, Haryana, Public Service Commission, Punjab and Haryana High court/District Courts etc. who want to appear in the Haryana State Accounts Services Examination, may be allowed subject to the condition that they shall submit an affidavit to the effect that they will not lay any claim for appointment to the Haryana State Accounts subordinate “Group C” Service Cadre on the basis of their participation and successfully passing the examination. Further their appointment will be subject to the vacancies existing in their respective organization. Result of such candidates will be declared separately.

Explanation:

- (i) "wholly owned" means an entity which is percent (100%) owned by the Haryana Government.
- (ii) "controlled" means an entity which is controlled by the Haryana Government, whether in regard to the proceedings generally or to specific matters such as the sanctioning of their budget, sanction for the creation or filling up of particular posts, or the enactment of leave, pension or similar rules.
- (iii) Employees of only those organizations will be eligible to appear in this examination whose entity is covered under both above (i) and (ii) explanations.

3. The Head of the Department of concerned employee shall certify that:-
- (i) The candidate is efficient and is likely to pass the examination.
 - (ii) The integrity of the candidate is above board as per instructions issued by the Chief Secretary, Haryana vide their letter No. 2759-4GSI-73/12854, dated 21.05.1973 and further amended from time to time.
 - (iii) The candidate has obtained 70% or more reports of "Good" or above grading during the last 10 years. In case the service of the candidate is less than ten years, then the criteria for ACR shall be in accordance with the length of service of the candidate.
4. Employees regularized under the State Government Policy No. 6/7/2014-IGSI, dated 16.06.2014, 18.06.2014, 07.07.2014 and 28.07.2014 shall be allowed to participate in the examination on provisional basis. However, it is made clear that mere participation in the slated written examination shall not create any right in equity so as to claim benefit thereof, in case candidates otherwise fail in SLP No. 31566 of 2018 titled as state of Haryana and others v/s Yogesh Tyagi and others pending before the Hon'ble Supreme Court of India in the matter of regularization of their services. Such candidates on passing of examination will not be considered for appointment on the post of Section Officer till the SLP attains finality.
5. If eligibility of any candidate is doubtful or subject to any proceedings/orders of any Court of Law, he/she shall not be eligible for this examination.
6. The Administrative Secretary to Government of Haryana, Finance Department reserves the right to reject any application for appearing in the Examination by giving duly recorded reasons thereof.

7. Application fee of Rs. 3000/- (Rupees Three thousand only) should be deposited by the candidate along with the application form. The fee once paid shall not be refunded in any case. It is further mentioned that those candidates who have already applied for HSAS, Part-I examination in the year 2021 shall again apply afresh for the examination but they are not required to deposit the fees again. They will only mention the GRN Number of fees already paid in the application form.
8. The following instructions should be kept in view by the Head of Department while verifying/certifying the application: -
- a) The application should be complete in all respects; incomplete applications will not be entertained.
 - b) All particulars entered in the application should be duly certified/verified by the Head of Department as per service book/record of the candidate.
 - c) Head of Universities/Boards/Corporations/Federations/Authorities will also certify that the organization is wholly owned (100%) and controlled by the State Govt. as per Explanation mentioned in para 3 of the Regulation.
9. The requisite document/certificates of the candidates will be verified after qualifying the HSAS Part-II exam. If any fact of a candidate is found incorrect at any stage his/her candidature is liable to be cancelled.
10. Other terms and conditions w.r.t. candidature and service will be governed by the Revised Regulations issued by Finance Department vide its letter No. 14/30/2021-1FA, dated 06.02.2023 which are available on www.finhry.gov.in and www.hrtreasuries.gov.in.
11. The application forms complete in all respects and duly verified by the Head of Department should be uploaded by **12.06.2023** on SARAL Web Portal(<http://saralharyana.gov.in>). The online portal will start on 23.05.2023 at 09:00AM and closed on 12.06.2023 at 11:59 PM. No application will be entertained in any form after the closing date.
