
Vide above letter, it was conveyed that Department has procured Annual Maintenance Contract on the behalf of all Departments of the State for more than 9,000 Digital Signature (e-Token) upto March, 2023. Now, HARTRON after inviting fresh bid has finalized new Rate Contract & support charges for purchase of new Digital Signature (e-Token) and certificates through M/s Bit4id India Pvt. Ltd. upto the validity of one year i.e. from 28.04.2023 to 27.04.2024 as per following terms & conditions:-

#	Cost components	Unit Rate
1	Digital Signature Certificate with USB tokens (Class 3 signing and encryption) with 2 years validity.	1,300/-
2	Digital Signature Certificate without USB tokens (Class 3 signing and encryption) with 2 years validity.	600/-

**Validity and e-Token warranty:-**

- i. The validity of the Digital Signature Certificate will be two years from the date of generation thereof.
- ii. An auto generated alert via email and SMS will be sent to the user before 45 days of expiry of their Digital Signature Certificate.
- iii. M/s Bit4id India Pvt. Ltd. will provide online dedicated support and helpdesk services through phone, email and SMS alerts by qualified and competent support team for assisting users of the concerned Department/office.
- iv. If any of the USB Token is found defective/ non-functional/ non-responsive within the warranty time period, M/s Bit4id will replace that USB Token with CLASS-3 DSC downloaded afresh, within 10 working days from the replace request. The concerned Department/office shall provide a fresh application for reissuance of CLASS-3 DSC, if required.
- v. The issuance process of Digital Signature Certificate tokens will be hassle free.


