ORDER

As per the provisions contained in the Existing Departmental Service Rules, the senior-most Assistant working in the Head-Quarter has the option to either go in the Field Cadre by the way of Promotion to the post of Assistant Superintendent Treasury (AST) and thereafter Assistant Treasury Officer (ATO) or to stay in HQ by the way of Promotion to the post of Superintendent in HQ itself. There is no provision in the Departmental Service Rules regarding going in Field Cadre as AST/ ATO and then taking reversion and returning back in HQ for promotion to the post of Superintendent.

But it has been observed that the above mentioned condition is being misinterpreted and misused by the senior-most Assistants of the Head Quarter as the Senior-most Assistant of HQ first goes as AST/ ATO in field and then returns back to HQ when the post of Superintendent in HQ becomes vacant. In this way, the Senior-most Assistant keeps getting double benefit of promotion at the cost of other Junior Assistants who remain in the HQ and resultantly do not get equal opportunities of Promotion.

Therefore, it is hereby decided and ordered that from now **if the Assistant of Headquarter gets or has been promoted as Assistant Superintendent Treasury (AST) in the Field Cadre, he/she shall loose the seniority of HQ from the day he/she gets promoted as AST. And further, after being promoted as AST or Assistant Treasury Officer (ATO), if he/she returns back to HQ as Assistant on his/her request, then his/her Seniority shall be fixed at the Bottom of the Seniority List as the Junior-most Assistant in Head Quarter.**


