4. 1 post is being kept due to Reservation of PwD's Quota and 4 posts are kept reserve consideration of Schedule Caste representation/roaster register.
5. The promotion will subject to condition that if any senior to the promoted employees will pass SETC in future, their seniority will be decided in terms of Rule-12 of Haryana Treasury Establishment Subordinate Group- 'C' Service Rules, 1980 and due to promotion of that, the number of Assistants increased beyond the sanctioned strength, the junior most Assistant will be reverted to his/her former post i.e. Clerk without giving any notice.
