- 1. These appointments are against purely temporary posts. Your services are liable to be terminated without assigning any reason by giving one month's notice or pay and allowances in lieu thereof, at any time.

If at any stage you desire to resign, You will be required to give one month's clear notice or deposit/ forfeit in lieu thereof one month's salary including allowances or for the period by which the notice falls short of one month in case of your temporary appointment and in case of your permanent appointment, you will be required to give three months clear notice or deposit/forfeit in lieu thereof your three months salary including allowances or for the period by which the notice falls short of 3 months.
