No Order earlier Department's In supersession of this TA-HR(5T)2025/4515-21 dated 14-07-2025, it is mentioned that as you are aware that the Health Department (Ayushman Bharat), Haryana has launched a Comprehensive Cashless Health Facility vide its Notification No. 2/22/2024/1-HB-III dated 07.06.2024. For the implementation of this scheme in Treasuries and Accounts Department, it has been decided by the competent authority to run a pilot for the registration of Regular Working Employees of Treasuries and Accounts Department Haryana and Pensioners (Retired from Treasuries & Accounts Department and drawing pension through Treasuries only).

The following actions are required to be taken for implementation of the said Scheme :-

- All the Regular Working Employees of Treasuries and Accounts Department and only Pensioners of this Department (Treasuries & Accounts Department Haryana) are required to register themselves on the Ayushman Portal for CCHF as per the instructions issued by the Govt. by 31.07.2025 positively.
- All the Treasury Officers will work as Nodal Officers in their concerned Districts to coordinate and assist Pensioners (only those who retired from Treasuries & Accounts Deptt. only) for their registration for CCHF Scheme.
- All working employees of Treasuries and Accounts Department (who reside outside Haryana) not having PPP ID, may apply for the same through Intra Haryana Portal.
- Pensioners of this Department (Treasuries & Accounts Department Haryana) who are drawing their pension through Banks shall be covered in the II<sup>nd</sup> Phase of the Scheme.
- It is also clarified that necessary orders for launching of Dependent Module under CCHF will be issued by Health Department/ Ayushman Bharat in due course of time.
