Subject: Regarding providing of benefit of entry level pay scale without regular annual increments for the post of Section Officer for the services rendered by the petitioners on the post of Section Officer (Part-I) on stop gap arrangement in view of order dated 04.10.2024 passed by Hon'ble High Court in CWP No. 1281 of 2020 titled as Shyam Sunder and Others Vs State of Haryana and Anr. read with interim order dated 11.07.2025 in LPA No.1989 of 2025 filed by the State in CWP No. 1281 of 2020 and in all other similarly situated cases.

Reference to this office letters memo no 3718019TA-HR(4T)-2025/498-503 dated 04,02,2025, memo no 3765476 TA-HR(4T)-2025/1416-33 dated 11.03.2025, memo no TA-HR(4T) -2025/655-72 dated 19.03.2025, memo no TA-HR(4T)-2025/3075-3124 dated 15.05.2025, with regard to subject cited above.

2. It is intimated that petitioners had filed various writ petitions (as per list attached) before Hon'ble High Court and Hon'ble Single Judge was pleased to dispose of all the said petitions relying upon mainly the judgement dated 17.11.2018 passed by the Hon'ble High Court in CWP No.7312 of 2016 in 'Baldev Krishan Sharma Vs State of Haryana and Others', wherein, Hon'ble Court had granted benefit of pay scale of Section Officer to the petitioner therein who had worked as Section Officer (Part-I) on stop gap arrangement and the said judgement has attained finality. However, in all other cases as per list attached,

the Hon'ble High Court has allowed these petitions directing the official respondents to pay to the petitioners regular pay scale of the post of Section Officers alongwith consequential benefits, which was not granted by the Hon'ble Court in the case of Baldev Krishan Sharma (supra).

In this situation, the government has decided to file LPAs in all the similar situated cases and accordingly this department has filed various LPAs before Hon'ble High Court. In one of LPAs, LPA No.1989 of 2025 fined in CWP No. 1281 of 2020 'Shyam Sunder and Others Vs State of Haryana and Anr.", the Hon'ble Division Bench vide its order dated 11.07.2025 was pleased to pass the following interim orders:-

"LPA-1989-2025 (O&M)

Learned counsel submits that while passing the impugned judgment dated 04.10.2024, the learned Single Bench has directed to release pay and allowances of the post of Section Officer for the period the writ petitioners have performed the duties of the said posts with all consequential benefits. He submits that the words 'with all consequential benefits' would also imply grant of increments and seniority, which could not have been done.

Notice of motion returnable for 17.11.205.

In the meanwhile, the effect and operation of directions 'with all consequential benefits' shall remain stayed"

In pursuance to the above mentioned interim order dated 11.07.2025, this Head Quarters had forwarded a proposal to the Government for obtaining approval regarding providing of benefit of entry level pay scale without regular annual increments for the post of Section Officer for the services rendered by the petitioners on the post of Section Officer (Part-I) on stop gap arrangement in view of order dated 04.10.2024 passed by Hon'ble High Court in CWP No. 1281 of 2020 titled as Shyam Sunder and Others Vs State of Haryana and Anr. read with interim order dated 11.07.2025 in LPA No.1989 of 2025 filed by the State in CWP No. 1281 of 2020 and in all other similarly situated cases.

The Government vide its letter memo no.29/28/2021-5FA dated 23.07.2025 has accorded its approval and directed the Head Quarter as under:—

- "2. After due consideration and in view of the fact that Hon'ble High Court has already granted partly stay in the LPA's filed by the State Government in similar cases, the Government has now decided as under: -
 - (i) The LPAs may be filed in all similar situated matters.
 - (ii) The order passed in CWPs may be complied, excluding the part stayed in LPAs and subject to outcome of LPAs.
- 3. You are, therefore, directed to act according to the decision taken by the Government and to file the LPAs in all the similar situated cases immediately under intimation to this office. The approval of Hon'ble CM has been obtained to file the LPAs in similar situated cases".
- 6. In view of the above, you are directed to provide the benefit of entry level pay scale of the post of Section Officer, without regular annual increments and without any consequential benefits to the petitioners related to your concerned department/ Board/ Corporation / University etc. for the services rendered by the petitioners on the post of Section Officer (Part-I) on stop gap arrangement in view of the orders passed by the Hon'ble Single bench in various writ petition as per list attached read with interim order dated 11.07.2025 passed by Hon'ble Division Bench in LPA No.1989 of 2025 in CWP No. 1281 of 2020, under intimation to this department and subject to final outcome of the LPAs being filed by the department.

In continuation of the above referred letter, further it is also clarified that the payment of arrears to Section Officers (Part-1) may be made at entry level pay alongwith Dearness Allowance/Dearness Pay only, where applicable as per instructions issued from time to time, but the arrears on account of any consequential benefit and other allowance of any kind may not be paid to the petitioners.
