

ORDER

After qualifying SAS (Part-II) examination the following candidates are hereby given subsequent appointment and posted in SAS Cadre as Section Officers against vacancy in FPL -7 (44900/-initial) Plus Rs. 100/- Special pay as per HCS (RP) Rules, 2016 on temporary basis on the following terms and conditions: -

1. They will be governed by Haryana State Accounts subordinate (Group-C) Service Rules, 2022.
2. The above appointment is subject to absence of adverse remarks regarding Integrity etc. in the pending ACRs. If any adverse remarks are noticed in the pending ACRs he/she will be reverted back to his/her parent department immediately.
3. They will be on probation for a period of one year which may be extended for further one year.
4. They will be treated as fresh entrant into the State Government Service. They will be governed by National Pension System (NPS) 2006.
5. The Govt. will not own any liability what so ever for the service rendered under Board/Corporation/Co-operative Institute/University/autonomous bodies etc. by them.
6. After appointment of Section Officer, their lien will be retained in the parent organization as per provision contained in Rule 30 of HCS (General) Rules, 2016.
7. If the above conditions are acceptable to them, only then they may join their new assignment as Section officer.
8. This is a purely initial temporary posting. All the Section Officers will be considered as per MOTP policy-2025 and any others instructions issued by Human Resource Department, Haryana on this matter.
9. They should be relieved immediately. They will have to submit their joining report with immediate effect of the issuance of this letter at Treasuries & Accounts Department Haryana Chandigarh.
10. The posting orders will be issued later on.
