

ORDER

After qualifying SAS (Part-II) examination Sh. Vikram Singh S/o Sh. Rajinder Singh Roll No. 2511351 is hereby given offer of appointment in SAS Cadre as Section Officer against vacancy in FPL -7 (44900/-initial) Plus Rs. 100/- Special pay as per HCS (RP) Rules, 2016 on temporary basis on the following terms and conditions: -

1. He will be governed by Haryana State Accounts subordinate (Group-C) Service Rules, 2022.
2. The above appointment is subject to absence of adverse remarks regarding Integrity etc. in the pending ACRs. If any adverse remarks are noticed in the pending ACRs he will be reverted back to his parent department immediately.
3. He will be on probation for a period of one year which may be extended for further one year.
4. He will be treated as fresh entrant into the State Government Service and he will be governed by National Pension System (NPS) 2006.
5. The Govt. will not own any liability what so ever for the service rendered under Board/Corporation/Co-operative Institute/University/autonomous bodies etc. by him.
6. After appointment of Section Officer, his lien will be retained in the parent organization as per provision contained in Rule 30 of HCS (General) Rules, 2016.
7. If the above conditions are acceptable to him, only then he may join his new assignment as Section officer.
8. This is a purely initial temporary posting. He will be considered as per MOTP policy-2025 and any others instructions issued by Human Resource Department, Haryana on this matter.
9. The posting orders will be issued later on.


