Notification

The 21st July, 1995

No. 52 GSR/Const./Art. 309/95.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Haryana hereby makes the following rule further to amend the Haryana Finance Department, Treasuries (Groups B) Services Rules, 1980, namely :—

1. These rules may be called the Haryana Finance Department, Treasuries (Group B) (First Amendment) Rules, 1995.

2. In the Haryana Finance Department, Treasuries (Group B) Service Rules, 1980, in Appendix 'E', for para 1, the following para shall be substituted, namely :—

“1. There will be three papers, First theoretical, Second practical and third Punjab Civil Services Rules, each carrying 150 marks as under :—
