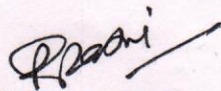

It is also directed to ensure that the above information is circulated to all Assistant Treasury Officers under your jurisdiction for necessary action and compliance.

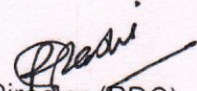
