## DISCLAIMER:

Qualified and eligible candidates are required to register on the MCC website i.e. www.mcc.nic.in to participate in the counselling process for allotment of seat. MCC does not allot any seat either on nomination basis or manually.
a) All questions in the scheme of counselling are mandatory in nature and not optional. Candidates are advised to go through these important questions related to the scheme of counselling before registering on MCC website, in order to understand the scheme of counseling.
b) Candidates are deemed to have read, agreed and accepted the Scheme of Counselling and the terms and conditions of the counselling scheme for NEET-UG Counselling on completing the online submission of application/registration form.
c) Application for NEET - UG Counselling can only be submitted online through Medical Counselling Committee website www.mcc.nic.in. Application submitted through any other mode shall be summarily rejected.
d) Candidates are further advised to fill the application form on their own on the mcc website.
e) A candidate can submit NEET-UG Counselling application/registration form only once. ## CHAPTER1- INTRODUCTION

## i. NEET UG Counselling

1. As per the ' Modified Scheme' approved by the Hon'ble Supreme Court of India, vide order dated 07.06.2012 passed in I.A. No. 35 / 2012 in Writ Petition (Civil) No(s). 443 of 1992 filed by Sharwan Kumar V/s DGHS \&Ors., Medical Counseling Committee of DGHS in Ministry of Health and Family Welfare, Govt. of India, New Delhi is conducting Online Counseling for allotment of Under Graduate (MBBS/BDS) seats to the eligible and qualified candidates under 15\% All India Quota in participating Government Medical/Dental Colleges of the country every year. The allotment of seat to the candidates is made based on the NEET-UG Examination conducted by National Testing Agency (NTA).
2. In addition, as per the directions of the Hon'ble Supreme Court of India dated 09.05.2017 passed in W.P. (C) No. 267/2017- Dar-Us-Slam Educational Trust and Ors. V/s Medical Council of India and Ors. , Medical Counseling Committee of Directorate General of Health Services is also conducting Online Counseling for allotment of Under Graduate (MBBS/BDS) seats to the eligible and qualified candidates in participating Deemed Universities of the country on the basis of NEET (UG) examination conducted by NTA.
3. Vide MCI Gazette Notification dated $27^{\text {th }}$ June, 2017, the Designated Authority for counseling for the $15 \%$ All India Quota seats of the contributing States and all MBBS seats of Medical Educational Institutions of the Central Government, Universities established by an Act of Parliament and the Deemed Universities shall be the Directorate General of Health Services, Ministry of Health \& Family Welfare, Government of India.
4. The scheme of Counselling was modified by the Hon'ble Supreme Court of India vide order dated 16.12.2021 in "SLA (C) No. 10487 of 2021 in the matter of Nihila P.P. v/s MCC \& Ors. wherein it was approved by the Hon'ble Supreme Court of India to conduct online 4 rounds of AIQ Counselling i.e. AIQ Round 1, AIQ Round 2, AIQ Mop-up Round, AIQ Stray Vacancy Round. Therefore, no seats will be reverted back to the participating States after completion of Round 2.
5. Vide Order dated 22.08.2017 the Hon'ble Supreme Court of India in W.P. (C) No. 689 of 2017 in the matter of Consortium of Deemed Universities in Karnataka \& Anr. v/s Union of India \&Ors. had issued directions stating that, $15 \%$ seats have to be allotted to the NRI Candidates in respect of UG seats (Medical/Dental) in Deemed Universities.
6. The Hon'ble Supreme Court of India vide Order dated $09 / 05 / 2017$ passed in Writ Petition (C) No. 267 of 2017 -Dar-Us-Slam Educational Trust \&Ors Vs MCI \&Ors. Directorate General of health Services, Ministry of Health \& Family Welfare had directed as follows:
"After the second round of counselling for All India Quota seats, the students who take admission in All India Quota seats should not be allowed/permitted to vacate the seats. This would ensure that very few seats are reverted to the State Quota and also All India Quota seats are filed by students from the all India merit list only. The students who take admission and secure admission in Deemed Universities pursuant to the second round of counselling conducted by the DGHS shall not be eligible to participate in any other counselling."
7. Keeping the above directions in view Candidates are advised to take a calculated decision of continuing in Second round of AIQ/Deemed/Central Universities as they would not be permitted to resign from 2nd round of AIQ/Deemed/Central Universities. They will also not be allowed to participate in any Counselling after joining in Second Round of AIQ.
8. As per the directions of Hon'ble Supreme Court of India in "W.P (C) No. 443 of 1992 Sharwan Kumar Vs. Dir. General of Health Services \& Anr." the following order has been issued
"If in implementation of the scheme any difficulties are felt by the Director General of Health Services or by any other person including the authorities in the States or by the Universities, they can approach this Court for necessary directions."
ii. Role of MCC in NEET

The MCC/DGHS will be doing Counseling for $15 \%$ AIQ, 100\% Deemed Universities, Central Universities (Delhi University, AMU \& BHU including Institutional/ Domicile Quota), ESIC, AFMC(only Registration Part) \&I.P University (VMMC \& SJH AND ABVIMS \& RML\& ESIC Dental, Delhi (15\% AIQ + 85\% Institutional Quota ) 100\% AIIMS, $100 \%$ JIPMER and B.Sc. Nursing (only 08 Central Institutes).
The role of MCC of DGHS is limited to allotment of seats to the participating candidates, as per their merit and choice, which starts only after receiving the list/data/Information of successful candidates from National Testing Agency i.e. the NEET (UG) examination conducting body.

## CHAPTER 2- 15\% ALL INDIA QUOTA

There will be four rounds of AIQ online counseling i.e. AIQ Round 1, AIQ Round 2, AIQ Mop-Up Round and AIQ Stray Vacancy Round (SLA (C) No. 10487 of 2021 in the matter of Nihila P.P. v/s MCC \& Ors. Hon'ble Supreme Court of India) which will be conducted in online mode. All candidates who have qualified for All India Quota seats on the basis of their rank in NEET UG conducted by the National Testing Agency (NTA) except the Union Territory of J\&K will be eligible. Eligible candidates may download the Rank letter/ Result from NTA website. Cut-off rank of eligible candidates will also be available on the MCC website (www.mcc.nic.in). No seats will be reverted back after the completion of round 2 of AIQ to the States.

## Open seats-domicile free includes:

i. $15 \%$ All India Quota seats MBBS/ BDS Seats of States (except Jammu \& Kashmir)
ii. $100 \% \mathrm{MBBS} / \mathrm{BDS}$ Seats of BHU OPEN
iii. AIIMS Open seats- $100 \%$ MBBS Seats of AIIMS across India
iv. JIPMER Open (Puducherry/ Karaikal)
v. AMU Open
vi. $15 \%$ All India Quota seats of DU/ I.P University (VMMC/ ABVIMS/ESIC Dental)
vii. Jamia Open seats- Faculty of Dentistry (Jamia Milia Islamia)
viii. 15\% All India Quota Seats of ESIC

## Reservation Policy for 15\% All India Quota seats:

Reservation Policy of the Central Government for the NEET-UG Counselling in All India Quota is as follows:

Reservation of seats under PWD Category is $5 \%$ in AIQ and the 21 Benchmark Disabilities as envisaged under the regulations of Rights of Persons with Disabilities Act 2016. For range of disabilities included, please see Annexure ' 1 '.

Candidates who want to avail 5\% PwD reservation in UG seats of Govt. /Central medical institutions should obtain Disability certificate as per 21 Benchmark Disabilities given under RPWD Act 2016, from the designated disability centres as per the list enclosed as ANNEXURE- 2.The certificate issued by any other hospital/ board will not be accepted.

Candidates declared Qualified/Eligible for All India Quota Undergraduate Seats (MBBS/BDS) only will be eligible for online allotment process for All India Quota

Seats, which is conducted by the Medical Counseling Committee (MCC), Ministry of Health \& Family Welfare, \& Government of India. For State Quota, Private medical and dental college seats the candidates are required to contact the appropriate State Government/Admission Authority \& Directorate of Medical Education. Medical Counseling Committee (MCC) will not be able to guide candidates in this matter.

## Roster:

The roster on the $15 \%$ AIQ seats shall be applied by the MCC of DGHS, MoHFW as per DoPT and MoHFW norms.

## Eligibility Condition for AIQ:

1. The Candidate should have qualified NEET UG.
2. Domicile free.
3. As per norms of NMC

* The conversion of seats will be carried out during the Mop Up Round for AIQ, Deemed, Central Universities/Institûtes, AIIMS, JIPMER, B.Sc. Nursing courses. The said conversion will be done only when the eligible Candidates belonging to the said Conversion Category have exhausted.

## CHAPTER 3- 100\% DEEMED UNIVERSITY

There will be four rounds of counselling i.e. Round 1, Round 2, Mop-Up Round \& Stray Vacancy Round. Out of the four rounds, three rounds will be conducted online by MCC i.e. Round 1, Round 2 and Mop-Up Round. The Stray Vacancy round shall be conducted by the respective Deemed Universities for which the list of registered Candidates for the Stray Vacancy round will be forwarded by the MCC to the Deemed Universities. All the candidates who have qualified for All India Quota seats on the basis of their rank in NEET UG conducted by NTA including candidates from Union Territory of J\&K will be eligible. Eligible candidates may download the Rank letter/ Result from NTA website.

## Reservation Policy:

* Candidates who fall under the category of NRI as per the directions/ orders of Hon'ble Supreme Court of India in the case (W.P. (C) No. 689/2017- Consortium of Deemed Universities in Karnataka (CODEUNIK) \& Anr. Vs. Union of India \&Ors.) dated 22-082017 are eligible for NRI Category. OCI/PIO/Foreign Nationals candidates will be considered as NRI. OCI/PIO/Foreign Nationals Candidates will only be eligible for NRI seats vide Ministry of Home Affairs Gazette Notification No. S.O.1050 (E) dated 04th March, 2021.
**Vide Order dated 08/11/2021 in W.P. (C) No. 1397 of 2020, the Hon'ble Supreme Court of India has directed as follows:
"The applicants and all other eligible candidates who are similarly situated are permitted to appear in the counselling in the General on par with Indian Citizens to pursue MBBS/BDS courses and other undergraduate/Post Graduate courses in approved/recognized Medical/Dental \& other Colleges/Institutes.
It is made clear that the aforesaid interim relief is limited to the academic year 2021-2022 only.

$>$ Affidavit from the sponsorer that he/ she will sponsor the entire course fee of the candidate duly notarized.
$>$ Embassy Certificate of the Sponsorer (Certificate from the Consulate).
$>$ NEET Score Card of the candidate.
There will be no reservation for $\mathrm{OBC} / \mathrm{SC} / \mathrm{ST} / \mathrm{PWD} / \mathrm{EWS}$ candidates in Deemed Universities.

There might be reservation for Jain Minority or Muslim Minority in certain deemed universities. Candidates are requested to verify their eligibility for the same before applying under the said category.

## Seat Matrix:

The seat matrix for the Deemed University seats shall be prepared by the MCC of DGHS, MoHFW.

## Eligibility Condition for Deemed University:

1. The Candidate should have qualified NEET UG.
2. Domicile free.

## JAIN MINORITY/ MUSLIM MINORITY/ NRI CONVERSION: JAIN MINORITY/

 MUSLIM MINORITY/ NRI seats remaining vacantduring the Mop-Up rounds will be converted to Private Deemed University seats after exhaustion of all the eligible Jain Minority/Muslim Minority/ NRI candidates to avoid any wastage of seats.The conversion of seats will be carried out during the Mop Up Round of Deemed, Universities. The said conversion will be done only when the eligible Candidates belonging to the said Conversion Category have exhausted.

## CHAPTER 4 - AIIMS

There will be four rounds of counselling i.e. Round 1, Round 2, Mop-Up Round \& Stray Vacancy Round for all AIIMS across the Country which will be conducted by MCC. All the candidates who have qualified for NEET-UG on the basis of their rank in NEET UG conducted by NTA including candidates from Union Territory of J\&K will be eligible. Eligible candidates may download the Rank letter/ Result from NTA website.

Certain specific eligibility conditions of AIIMS are different from those highlighted in the NTA Information Bulletin. Eligible and willing candidates are advised to keep a note of the same before choice-filling. A copy of the same is annexed at Annexure- 6

Candidates are advised to go through the Information Bulletin of AIIMS for checking the eligibility conditions, seat status etc. before applying for the same. In case the said eligibility conditions are not fulfilled, the seat is likely to be cancelled.

Candidates who want to ayail $5 \% \mathrm{PwD}$ reservation in UG seats of Govt. /Central medical institutions should obtain Disability certificate as per 21 Benchmark Disabilities given under RPWD Act 2016, from the designated disability centres as per the list enclosed as ANNEXURE- 2. The certificate issued by any other hospital/ board will not be accepted.
** For the Foreign National seats NRI/OCI/PIO/Foreign Nationals candidates will only be eligible for NRI seats and UR seats for the academic year 2021-22 vide Order dated 08/11/2021 in W.P. (C) No. 1397 of 2020, the Hon’ble Supreme Court of India has directed as follows:
"The applicants and all other eligible candidates who are similarly situated are permitted to appear in the counselling in the General on par with Indian Citizens to pursue MBBS/BDS courses

There will be four rounds of counselling i.e. Round 1, Round 2, Mop-Up Round \& online Stray Vacancy Round for ESIC which will be conducted by MCC. All the candidates who have qualified for NEET-UG on the basis of their rank in NEET UG conducted by NTA will be eligible. Eligible candidates may download the Rank letter/ Result from NTA website.

Ans: Since it is online allotment (Online Counseling) process, no documents will be required for participating in online allotment process during Registration process.

## Q. No. 5: How and when I had to make the payment?

Ans: After registering for fresh registration, payment page appears automatically. Candidate can do online payment by Net Banking / credit card/ debit card only after making the payment as per choice. Only after the successful payment candidate proceed for choice filling.
Q. No. 6: Is there any restriction for filling up number of choices of Institution (College) (and courses i.e. MBBS, BDS and B.Sc. Nursing) in choice filling form? Ans: No, you can give as many choices as you wish during online choice filling. However choices should be in order of candidates' preference. There will be common
software for AIQ/ Deemed/ Central Universities//B.Sc. Nursing/AIIMS/JIPMER/AMU/BHU for filling up choices.

## Q. No. 7: Can I have some idea about the seat I am likely to get at my rank?

Ans: You can have some idea from the following:
A. Please $\log$ on to website - from home page go to medical counseling - open UnderGraduate (for previous years) - open composite allotment list. From the information that you will see, you get some idea of pattern in previous year(s). This will only be indicative (without any guarantee for the current year). Opening and Closing rank course and category-wise is also available in Download section of home page of MCC website.
B. From result of Mock Counseling and Indicative Seat Allotment (during the registration period/ during round-1)
Q. No.8: Is it necessary to fill up the choices and lock the choices to get seat allotted? Or I will be allotted seat automatically from leftover seats?
Ans: After online registration (registration is compulsory to take part in online allotment process, before the round -1 during specified registration period), you have to fill in choice of Institutions/colleges/courses in order of your preference. Once choice is filled in, it can be modified before locking it. During the choice locking period, it is necessary to lock the choices to get a print of your submitted choices. If candidate does not lock the choice submitted by him/her, it will be automatically locked as per schedule.

If you don't register and fill in choices during registration period, you will not be allotted any seat. Please also note that registration will be available once before allotment of round-1, before starting of round-2 and before start of Mop up Round. There will be no fresh registration before Stray Vacancy Round.

## IMPORTANT:

Don't wait till the last minute to Register and Lock your choices and to take a printout. Please go through your submitted choices before locking, as once you lock the choices they cannot be modified or changed even if you have made a mistake. It may result in allotment of a seat which you never wanted. (Please note that the choices once locked cannot be unlocked even from MCC)
Q. No. 9: Is it necessary to join allotted Medical/Dental College of Round 1 to get chance to participate in Round 2?
Ans: No, candidates need not report or join the allotted college of Round 1 since there is free exit.
However if they want to hold the Round 1 seat they have to physically join the college of Round 1 and give up-gradation willingness for Round 2 at the time of admission.

## Q. No. 10: If a candidate does not report at the allotted college during Round 2 whether he has to register again for Mop Up round? <br> Ans:- Yes, Candidate security amount will be forfeited and he has to register fresh in Mop Up round with Fresh Payment.

## Q. No. 11: If some new Under-graduate seats are created / started (increase in UG seats or in new medical/Dental colleges) after start of online counseling, will these be included and when?

Ans: Newly created/sanctioned seats that could not be included in first round due to non-reporting / late reporting/ reporting after start of first round of online allotment process, will be included in second round (Round-2) on receiving information from participating Medical / Dental Colleges before the start of second round (publication of the seat matrix).

## Q. No. 12: Who are eligible for 2nd Round of allotment?

Ans: Candidates eligible for seat allotment in 2nd round would be from one of the following groups:

Group-I: Registered candidates who did not get any seat allotment in the 1st round.
Group-II: Registered candidates who have secured seat under reserved quota \& whose 1st round of allotted seat got cancelled during the document verification on reporting for admission will be considered for allotment of seat in the next round of seat allotment, with changed Category, subject to availability of seat in respective category.

Group-III: Candidates who have reported at allotted institute during 1st round of allotment and submitted willingness for second round up-gradation as Yes.

Group- IV: Candidates who have been allotted a seat but Not Joined.
Group V: Candidates who have resigned from the allotted seat of first round at college.

## Q. No. 13: Who are not eligible for 2nd Round of allotment?

Ans (a) Candidate who has become non eligible due to having inadequate documents as per Eligibility Criteria.
(b) Who have not registered in Round 1 or Round 2.

## Q. No 14: What is the procedure for Second round (round-2)?

Ans: 2nd round of Counseling: Fresh set of seats gets added to the system (seats available during round-1), if any, which is due to latest approvals of NMC/DCI (increase in admission capacity of existing Medical/Dental College/ starting of new Medical/Dental college). Further, the conversion of seats is also carried out during the Mop Up Round and accordingly, the candidates are required to be shown all choices (seats available and likely to be available) which are against vacant, newly added seats, virtual vacancies which are likely to get vacated during up-gradation and also
during the conversion of seats as per the following algorithm:

During participation in round 2 and mop-up candidates are required to submit fresh choices online during the time the window is open for the same. Choices which were filled during 1st round of choice filling will be null $\&$ void.
All eligible candidates (as shown below) who desire to take part in second round, Mop Up Round of online allotment will have to submit fresh choices during choice submission period and lock the choices during period of locking.
There will not be any indicative allotment in Round-2 or subsequent rounds of allotment, locked choices of the candidates would be processed and result will be published. Those candidates, who do not submit fresh choices for the round-2 and subsequent rounds of counseling, would not be considered.
Q. No. 15: Can a candidate participate in second round without submitting fresh choices (based on choices submitted before round-1)?
Ans: Fresh choice submission by eligible candidates, as mentioned above is necessary for consideration for seat allotment during round-2. If candidate does not submit fresh choice(s) during choice filling period, the candidate will not be considered for allotment of seat during Round- 2 and will retain the already allotted (joined) seat, if any.
Q. No. 16: Do I haye to fill in choice of College/Course to participate in second round of online allotment process?
Ans: Yes. All candidates who desire to take part in second round will have to submit fresh choices before second round.
Q. No. 17: After $I$ join Second Round of Counseling of AIQ/Deemed/Central/AIIMS/JIPMER/Nursing can I leave/ Resign to join State Quota/ Private College seat?
Ans: Once you join second round seat, you will not be allowed to vacate from allotted 2nd round seat as per direction by Hon'ble supreme court in WP(C) (267/2017) dated 09/05/2017.However if you are allotted a seat in Second Round and have not joined the college/institute in AIQ/

Deemed/Central/AIIMS/JIPMER/Nursing you can Exit with Forfeiture of security amount.

## Q. No. 18: If I give consent for up-gradation of my choice during first round and if my choice is allotted, is it necessary to join at college allotted during second round?

Ans: In case candidate is upgraded during the second round of allotment process, the seat allotted during the first round will be automatically cancelled immediately (and allotted to somebody else) and candidate will have to join the college/seat allotted during second round after obtaining online generated relieving letter from college allotted in Round-1. If a candidate does not join the college/seat allotted during the second round, within stipulated period, he will forfeit his Fee and will have to register again to participate in Mop - up Round.

Seat can also be up-graded in the same college (same course) by change of category (i.e. $\mathrm{ST} / \mathrm{SC} / \mathrm{OBC} / \mathrm{EWS} / \mathrm{PwD}$ to UR) in such a case also the candidate has to take fresh admission on the up- graded seat, as per procedure.

## Q. No. 19: If I forget my password that I have created during the process of registration, how to retrieve it?

Ans: To retrieve the forgotten password, system facilitates the following process: The candidate is required to enter the information that he/she filled at the time of registration and then security question \& answer thereon to be entered as given during New Candidate registration process. The above data submitted by candidate will be validated with the registered candidate's database. If the above entries match, then only the candidate would be permitted to enter new password to proceed further.

## Q. No. 20: Difficulty in login, what may be the problem(s)?

Ans: Please read user manual for the candidates. Follow the instructions about use of browser, use of same spellings, same format of date (Use digits for day, month and year with - in between) as in application form submitted to NTA, New Delhi. The internet connection should be uninterrupted. If internet connection interruption takes place, the IP address which is being monitored by the Counseling Software, will change and session expired message will be displayed. In such case, please try to login from other computer having uninterrupted internet connection from which other candidate(s) has logged in successfully, .

Q No. 21: I have difficulty in creating Password, what may be the problem(s)? Ans: Creation of password should be as per password policy. Please follow the password policy. Please use the internet browser as suggested in user manual, as it is difficult to login from some of the other browsers. While creating password avoid using Caps Lock key, instead of Caps Lock key, use shift key.
Q. No. 22: When I try to login for choice filling/ submission, it say wrong roll number/ password, what may be the problem(s)?
Ans: This can happen if roll number typed is incorrect or password typed is incorrect. Password is ca se sensitive, therefore use password which was created by user exactly same as typed while creating. In case password is forgotten, try to retrieve password by using security question and its answer.
Q. No. 23: What are the guidelines for fresh choice filling before second round of online allotment process?
Ans: Please remember that if any seat is allotted (in round-2) from the choice filled in by the candidate before 2 Round of Counseling, the seat allotted during 1st round will be automatically cancelled. Therefore, the candidates are advised to fill in choice carefully for seats which are of higher preference than the earlier allotted seat. Candidates are not required to fill up seat which is already allotted to them (already joined), in their choices during Round-2.
Q. No. 24: Can I modify my choices during the period of "Exercising of Choices and Locking" (during first round) and "Fresh Choice submission and locking for 2nd Round and subsequent rounds".
Ans: Yes, you can modify, add or delete your choices during this period, before you lock your choices. But once you lock your Choices then you cannot modify. However, the registration (of New Users) is permitted up to specific date as mentioned in Counseling Schedule.
Q. No. 25: How can I get print out of my choices which system has locked?

Ans: as per schedule on the last date of locking/ after locking of choices by the system, you will be able to take a printout of your submitted choices, during the first, second \& Mop Up round of seat allotment and admission. You will also be able to see your locked choices and able to take a print out of the same at allotted Medical / Dental College at the time of admission on request.
Q. No.26: If I opt to participate in second round of counseling whether my allotted seat (of first round) will be cancelled?
Ans: In case you are not allotted any seat in the second round, you will retain earlier allotted seat in Round 1. However on up-gradation of a seat in second round, the earlier allotted seat in Round 1 will automatically be cancelled and allotted to another candidate. Therefore, you are advised to fill in only higher choices or any other choice which you prefer over the earlier allotted seat, for second round.
Q. No. 27: If I get an up-graded seat during second round, can I join that college directly?
Ans: No, you will have to get online generated relieving letter from the earlier institute/ college (from MCC software - will be given by the college authority), before you join the next college / institution. Without such relieving letter candidate will not be permitted to join the seat allotted in round-2. Up-gradation is applicable only those candidates who have joined allotted seat of Ist round and submit willingness for up gradation.
Q. No. 28: If I lock my choices and later I want to modify/ edit my choices, is it possible?

Ans: Once candidate lock the choices it is not possible to unlock the software from MCC end. Hence, candidate is advised to check all choices before locking.
Q. No. 29: In case I get an upgraded seat but in the same college, because of change of category, (e.g. from SC or ST to UR category) do I have to take admission on the allotted seat again?
Ans: Yes, you have to get a relieving letter generated on-line for the earlier seat and then get an admission letter again generated on-line for the upgraded category seat from the concerned institution; otherwise your seat will be cancelled and allotted to another candidate.
Q. No. 30:- What is the procedure for Mop Up Round Counseling which will be conducted by DGHS for AIQ/Deemed/Central Universities/AIIMS/JIPMER/Nursing?
Ans. The net vacant seats due to non joining, non reporting of Round 2 will be published in the seat matrix and eligible candidates have to submit fresh choices and the result will be processed as per Choice $\&$ Merit.
Q. No. 31:- What to do If I by mistake I had opted for Deemed Universities seats when I wanted to opt only for All India Quota (AIQ). How do I correct it?
Ans. There is a reset initialization option at registration page where candidate can reset the previous filled quota choice and fill the particular again and then proceed for registration. This facility is provided only once. However, candidate has to make new registration with full payment of fees after using RESET option.
Q. No. 32:- Whether Up-gradation is allowed from 2nd round counseling of AIQ/Deemed/ Central Universities/AIIMS/JIPMER/Nursing to Mop-up Round counseling of DGHS for AIQ/Central / Deemed

## Universities/AIIMS/JIPMER/Nursing?

Ans. No, Up-gradation is not allowed once a candidate joins a seat allotted in Round II of AIQ/Deemed/ Central Universities/AIIMS/JIPMER/Nursing and the candidate will not be allowed to vacate the seat of AIQ/Deemed/ Central Universities/AIIMS/JIPMER/Nursing. The candidate will not be allowed in any further counseling including Stray Vacancy Round of AIQ/Deemed/ Central Universities/AIIMS/JIPMER/Nursing.

## Q. No. 33: Who are Eligible for Stray Vacancy Round of AIQ/Deemed/ Central Universities/ AIIMS/JIPMER/Nursing?

Ans. All Registered Candidates except the following three categories are eligible for Stray Vacancy Round of AIQ/Deemed/Central Universities/AIIMS/JIPMER/Nursing:-
a) Candidates who joined the allotted seat in Round II of AIQ/ Deemed/ Central Universities AIIMS/JIPMER/Nursing.
b) Candidates allotted a seat in Mop Up Round of MCC and NOT REPORTED.
c) Candidates joined a seat in Mop Up Round of MCC.

## Q. No. 34: Who are not eligible for Stray Vacancy Round of AIQ/Deemed/ Central Universities/ AIIMS/JIPMER/ Nursing?

Ans. Following Candidates are not eligible:-
a) Candidates who joined the allotted seat in Round II of AIQ/ Deemed/ Central Universities/ AlIMS/JIPMER/Nursing.
b) Candidates allotted a seat in Mop Up Round of MCC and NOT REPORTED.
c) Candidates joined the allotted seat in Mop Up Round of MCC.
d) Candidates who have not registered in any of Previous 3 Rounds.

## Q. No. 35: Will there be any Fresh Registration for Stray Vacancy Round?

Ans. No, there will be no Fresh Registration for Stray vacancy Round. The 10 times vacant seats list of registered candidates will be provided by DGHS to Deemed Universities for Stray Vacancy Round as per the direction of Hon'ble Supreme Court directions and as per regulations of MCI.
Stray Vacancy Round for AIQ/Central University AIIMS/JIPMER/Nursing seats will be conducted by MCC of DGHS in online mode.

## Q. No. 36: Whether I am eligible for State Quota if allotted a seat in IInd Round of DGHS?

Ans. If a candidate has been allotted a seat in Round II but not reported at the allotted Institute he/she can exit with Forfeiture of Fees i.e. the Refundable security amount will be forfeited. However once the candidate joins a seat allotted in Ind Round (of AIQ/ Deemed/Central University/Nursing) he/she will not be eligible for exiting the seat and not eligible for any other round of Counseling including State Counseling. The names of such candidates who have joined in Round II of AIQ/ Deemed/ Central Universities/Nursing may be circulated to all state counseling authorities for prohibiting them to participate in any other counseling.

## Q. No. 37: How much time will I be given to join the allotted college?

Ans: Candidates allotted seats will be required to join the allotted college/course within stipulated time which is mentioned in counseling schedule. However, candidates are advised to join as early as possible and not to wait for last day of joining, due to different schedule of holiday (including local holidays) / working hours in various Medical / Dental Colleges. In some of the colleges/ universities, 2-3 days' time is required to complete admission formalities. Therefore, candidates are advised to contact allotted college immediately after declaration of result of counseling allotment process, to know the details. If candidate fails to join the allotted Medical/Dental College within stipulated time, then the allotted seat will be cancelled.

Please note that under no circumstances date of joining can be extended by the MCC.

## Q. No. 38: What documents are required at the time of Joining/ Reporting in allotted Medical/Dental/Nursing College?

Ans: Original documents (along with attested photocopies of documents) for admission to under- graduate medical/dental/nursing courses for admission to allotted college are required at the time of joining in allotted Medical / Dental College are as mentioned below.

a) Passport copy of sponsorer, embassy certificate
b) Sponsorship affidavit (stating that sponsorer is ready to bear the expenses for the whole duration of study)
c) Relationship Affidavit (Relation of Candidate with the sponsorer)
XI. The Candidate should also bring the following certificate, if applicable:
(a) SC/ST Certificate issued by the competent authority (in the standard format as specified in the prospectus/information bulletin) and it should be in English or Hindi in language. Sub caste should be clearly mentioned in the certificate. Some of the States insist for English version of Caste Certificate. In case the certificate is in regional language the candidate should carry a Attested translated copy of the certificate in English/ Hindi.
(b) OBC-NCL as per Central List certificate issued by the competent authority. The sub- caste should tally with the Central List of OBC. The OBC candidates should not belong to Creamy Layer to claim OBC reservation benefit. The OBC certificate must be in the standard format as mentioned in the prospectus/ Information Bulletin.
(c) Disability Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act 2016 (RPWD Act, 2016). No other PWD certificate, issued by any other Authority/Hospital will be entertained.
(d) EWS Certificate as per the prescribed format.
(Candidates are advised to see college information, of allotted college for, any other document which may be required by the allotted college)
Candidates without original certificates/documents shall not be allowed to take admission in allotted Medical/ Dental College.

## Q. No. 39: In case I have Birth Certificate / Caste Certificate/ other certificate(s) in regional language, will it be acceptable at the time of reporting?

Ans: Certificates issued by the competent authority on standard format, should be in English or Hindi language. Please remember that some of the states insist for certificate in English language only. Candidates are advised to carry certified (attested) Copy of English version of the original certificate, in case certificate issued is in other than English language, along with original certificate.
Q. No. 40: If there is discrepancy in spelling of name in documents and application form, what do I do?
Ans: If there is discrepancy in spelling of name in documents, candidate must carry proof that the documents belongs to same person, in the form of an affidavit.

## Q. No. 41: What if I do not have my Original Documents with me at the time of joining the allotted college?

Ans: The Candidates who have been allotted a seat through NEET UG Counselling by MCC are informed that their admission is provisional subject to physical verification of documents by the allotted college authorities. The MCC has no role to play in physical verification of documents.
Candidates who have deposited their original documents with any other Institute/ College/University and come for admission with a certificate stating that "their original certificates are deposited with the Institute / College University" will not be allowed to take admission in allotted Medical/Dental College.

## Q. No. 42: Will NRI/OCI/PIO/Foreign national Candidate be shown seats

 reserved for Jain Minority/Muslim Minority?Ans: No. As per the policy of MoHFW any Candidate who is NRI/OCI/PIO/Foreign National will not be shown seats reserved for Jain Minority/Muslim Minority. One Candidate can only opt for one type of reservation.
Q. No. 43: What are the changes/modifications in the counselling scheme which will be implemented from the academic year 2021-22?

Q. No. 44: What is the criteria for OBC reservation in Central Institutes of IP University?

Ans: The rules of Central Institutes/University and the OBC list as per Central Rules will apply.

## CHAPTER 13-APPLICATION FORM \& FEE OF COUNSELING

## i. Fees

Q. No. 1: What about condition of Stipend / fee structure / course duration / bond amount/rendering of service in rural /tribal area/NRI fees/other conditions applicable in various Colleges/ States?
Ans: MCC collects the college information from the participating College/Institute/University for the benefit of the participating candidates. The same is made available on MCC website under heading of College Information. Candidates are advised to study the same.

Stipend /fee structure/ course duration / bond amount / rendering of service in rural / tribal area/ NRI fees/other conditions etc. may vary from State to State and Institute to Institute. Some seats may be approved/ permitted but not yet recognized by $\mathrm{MCI} / \mathrm{DCI}$. The allotment made through online allotment process will be firm and final as per Hon'ble Supreme Court's guidelines. Therefore, the candidates should well examine these points before opting for a seat at a medical college. The Medical Counseling Committee (MCC) shall neither be responsible nor shall entertain any case on above grounds, if any. The information received from various participating Medical / Dental Colleges has been made available on Medical Counseling Committee (MCC) under College Information heading. Candidates are advised to visit the website of college/ institution also to check the information. In case they require any additional information, they can contact the college / institution on telephone.

## Q. No. 2:- What are the various fee to be paid at the time of registration?

Ans: At the time of registration students participating for
Medical/Dental/B.Sc. Nursing seats will have to pay two kinds of fee:

## For Deemed Universities

Non Refundable Registration fee:-Rs. 5000/-(same for all candidates)
Refundable Security amount:-Rs. 2, 00,000/-
e.g Any candidate opting for Deemed University will have to pay Rs 5000/- Non Refundable fee + Rs $2,00,000 /-$ Refundable security amount at the time of at the time of Registration.

For (15\% All India Quota)/ Central Universities (DU, AMU, BHU and Jamia Millia Islamia, Delhi)/AFMC\& ESI/ All AIIMS/ JIPMER/B.Sc. Nursing

Non Refundable Registration fee:-Rs. 1000/- for UR candidates \&Rs. 500/- For SC/ ST/ OBC/ PH candidates.
Refundable security amount:- Rs.10,000/- for UR candidates \&Rs. 5,000/- for SC/ST/OBC/PHe.g. any UR candidate opting for Central Universities/ AFMC/ ESI will pay Rs. $1000 /-+$ Rs. $10,000=$ Rs. 11,000 at the time of registration.

Any $\mathrm{SC} / \mathrm{ST} / \mathrm{OBC} / \mathrm{PH}$ candidate will pay Rs. $500+$ Rs. $5,000=$ Rs. 5,500 at the time of registration.
Candidates applying for the NRI Category are advised to verify the mode of payment from the concerned college.
Q. No. 3:- In case candidate had to apply for both Govt. Medical/Dental/Nursing and for Deemed University should the candidate pay the fee for both?
Ans. No. As per the policy, the candidate has to pay only the higher fee. In this case the candidate will have to pay fee for Deemed University i.e. Rs. 5000/(counselling/registration) plus Rs. 2,00,000/- (security amount).

## Q. No. 4: What does exit with forfeiture mean in 2 nd round and subsequent round of counselling?

Ans: Exit with forfeiture means if a candidate allotted a seat in 2 nd round or subsequent round of counseling and does not want to join the allotted seat he can still exit with forfeiture (losing security amount deposited) and once candidate joined the allotted seat would not be eligible for resigning/surrender of joined seat.

## ii. Refund

## Q. No.1: When and where this Security Deposit will be refunded?

Ans:

1. Security amount will be refunded only after the completion of all rounds of Counseling. MCC will notify about the completion counselling on their web-site "www.mcc.nic.in". The Financial Custodian will initiate the refund of security deposit within 15 days of such notification and complete within 30 days of such notification.
2. The security amount will be refunded to the same account from where the security amount was initially deposited by the candidate. E.g.
1) If the security amount was deposited

Hence, the candidate must keep their card/bank account ACTIVE till refund process is completed. If card/bank account is closed before the completion of refund, the bankers will not be able to complete the refund process. Since bankers will take long time to identify \& return the failed refunds to Financial Custodian and legal formalities are to be complied for initiating refund to different bank account, refund to new bank account will take very long time. Neither Financial Custodian nor MCC will be responsible for such delay.
Q.NO.2: If the security deposit is remitted through unrelated card/bank account can the candidate request for refund to different card/bank account?

Ans: NO. MCC will not entertain such requests. The security deposit will be refunded only to the account from where the security deposit was initially deposited. The candidates are advised to not use unrelated card/bank accounts for remitting security deposit.
Q. NO. 3: What happens if the candidate, by mistake, makes more than one payment for the same Roll\#?

Ans: Candidate can approach the Financial Custodian after 15 days of closing of Registration Window. The Financial custodian will refund the excess payment, if any, within 30 days of closing of Registration Window. The financial custodian will deduct $50 \%$ of the Regn. Fees or Rs. 500 /whichever is less from each excess receipt refund towards Admn. Expenses.
Q.NO.4: Do I have to request the Financial Custodian to refund the security amount? What is the schedule for refund of security amount?

Ans: NO. Candidate need not approach the Financial Custodian for refund of security amount. The Medical Counselling Committee will publish the list of candidates who are eligible for the refund of security amount on the website of MCC "www.mcc.nic.in"once all rounds of counseling are completed. The Financial Custodian will initiate the refund of security amount within 15 working days and complete the refund of security deposit within 30 days of publishing the eligible list in the MCC Website. Once the Financial Custodian completes the refund, MCC will publish the refund details along with refund date \& transaction \# in the website of MCC "www.mcc.nic.in" within 45 days of publishing the eligible list in the MCC Website. The refund will be credited, depending upon the level of digitalization of candidate's bank, to the candidates account between 2 to 15 days from the date of refund by Financial Custodian.

## Q.NO. 5: Can candidate initiate refund proceedings through chargeback claim through

 the card Issuing bank?Ans: NO. Candidates who have been allotted Roll \# should not initiate refund proceedings through charge back claim through the card issuing bank. If the charge back claim is initiated, the Financial Custodian /MCC will be debarred by the Payment Gateway Service Providers from initiating direct refund. The candidate has to approach only their card issuing banks for refunds. For initiating manual refund by Financial Custodian, the candidate should withdraw the charge back claim and produce a no objection certificate from card issuing bank stating that the charge back claim is withdrawn \& card issuing banker do not have any objection in Financial Custodian refunding the deposit. As this process takes lot of time and the refund will be inordinately delayed. Hence candidates are advised to not to initiate chargeback claim.

## Q.NO. 6: Who is the Financial Custodian?

Ans: HLL Lifecare Ltd, a Govt. of India Undertaking under Ministry of Health and Family Welfare is the Financial Custodian. They will, on behalf of MCC, collect non-refundable Registration Fees and refundable security deposit from the candidates and refund the security deposit to the candidates.

## Q.No.7: How to contact the Financial Custodian?

Ans: The Financial Custodian Can be contacted through email"financemcc@lifecarehll.com" The Financial custodian will respond only to the mails through mail id registered in the application form.

Ans: NO. Bank Charges if any, incurred by the candidate should be borne by the candidate only.
Q. No. 9: Can candidate remit the Registration Fee and Security Deposit from NRI Account?

Ans: NO. MCC cannot, as per Reserve Bank of India (RBI) Rules, refund security deposit to NRI Account. If the candidate wants to use the funds available in his/ her NRI Account for registering for counseling, he /she has to first transfer funds from NRI Account to NRO Account and from NRO Account to MCC. The refund from MCC will be credited to NRO Account only.
Q. No.10: Will MCC pay interest on the refundable security deposit?

Ans: NO. MCC will not pay interest on the refundable security deposit.

Medical Colleges are as under:

1. Candidate should have Ward of IP Certificate with distinct number.
2. Candidate should have qualified All India examination i.e. NEET UG for the relevant year.
3. Reservation for the MBBS/BDS seats under Insured Persons' Quota for 202122 would be as per extant Govt. of India guidelines.

Like in previous years, ESIC has no objection to the DGHS following the reservation roster as is followed for 15\% All India Quota.

## Note:

1. Seats may be added/deleted depending upon the status of approval from University/National Medical Commission/Dental Council of India/Ministry of Health \& Family welfare (MOHFW) Government of India. However, in case of any increase in intake capacity in MBBS/BDS course (s) the same will be displayed before the start of the counseling sessions).
2. The candidates are advised to see website of Faculty of Medical Sciences / Medical Counseling Committee for distribution of seats.

## Normal Duration of Courses.

MBBS Course: The normal duration of the course is $41 / 2$ years, followed by one year compulsory rotating Internship Training.

BDS Course: The duration of the course is 4 years, followed by one year compulsory rotating Internship Training.
2. Eligibility Conditions/Requirement for admission to MBBS/BDS Courses under 85\% Delhi quota:-
(a) Age: The candidates should have completed the age of 17 (seventeen) years on or before 31 st December 2021. The candidates completing the age of 17 years on $1^{\text {st }}$ January 2022 or later on will not be eligible for admission, i.e., the candidate must be born on or before 31.12.2004.

Further to become eligible for $85 \%$ Delhi Quota, the candidate must have passed $11^{\text {th }}$ and $12^{\text {th }}$ standard examination under $10+2$ system conducted by CBSE/Indian school certificate examination/Jamia Millia Islamia, New Delhi or any other equivalent examination from a recognized school situated within the NCT of Delhi only. (see Appendix I)

(ii) The Candidates who have passed qualifying examination from Patrachar Vidyalaya or National Institute of Open Schooling will be eligible for admission in MBBS/BDS courses under 85\% Delhi Quota provided their study center and the examination Center were within the National Capital Territory of Delhi (NCTD) and they must upload a certificate from the controlling authority of Patrachar Vidyalaya/NIOS in this regard.


NOTE:-However, the candidature of candidates who have passed the qualifying examination ie. $10+2$ from NIOS or state of open school or as private candidates from recognized state boards, or with Biology/Biotechnology as additional subject shall be allowed subject to the outcome of the special leave petitions/Appeals filed by National Medical Commission (NMC).

With reference to your email dated 05.10 .2021 , the Eligibility criteria for Puducherry UT domicile category is furnished in the enclosure. It may be noted that

1. The furnished eligibility criteria for Puducherry UT domicile category is applicable for all rounds of counselling including stray vacancy round.
2. The Internal quota may be referred to as 'JIPMER Puducherry UT domicile' and the 'Open' category may be referred to as 'JIPMER All India' to avoid confusion in nomenclature. (as intimated to you in our email dated September 24, 2021).
3. Registration of Puducherry UT domicile students: The list of verified Puducherry UT domicile students obtained from NEET nodal officer for Puducherry UT will be forwarded to MCC before the beginning of registration for counselling. MCC may do the needful to set up a filter with the help of NIC such that the field for selecting Puducherry UT domicile category will be enabled only for these verified candidates at the time of counselling registration.

## Enclosure: Eligibility criteria for Puducherry UT domicile

## I. Puducherry UT Domicile - Definition:

A candidate is considered to be domicile to the UT of Puducherry (P-UR), if he/she satisfies at least one of the following domicile criteria (Refer to Annexure in JIPMER MBBS Prospectus for the Format of Certificates)
a) Those candidates or whose parent (either mother or father or both) or Guardian (in the case of children who have lost both parents) have been residing continuously in this Union territory for at least five years immediately preceding the closing date of NTA NEET 2021 application.
b) Those who have passed SSLC/HSC or any other public examination and for that purpose had undergone academic studies continuously for 5 successive classes immediately preceding the qualifying examination (including the year of the qualifying examination) in recognised educational institutions(s) located in Puducherry Union Territory and having their residence in the Puducherry Union Territory for five years continuously during that period.
c) Children whose parents are Central Government Servants, Employees of Central Government Autonomous institutions, State Government Servants, Defence Personnel, Central Paramilitary Forces, Employees of Public Sector Undertakings wholly or substantially run either by the Central Government or by the Puducherry Union Territory administration, posted and serving in the Puducherry Union Territory for at least a minimum continuous period of three years immediately prior to the last date of submission of application and the children of the above said employees should have studied in the Higher Secondary Course of two years in any of the schools in the U.T. of Puducherry and should have also passed the Higher Secondary Examination from the same school. [G.O. Ms. No. 04, Puducherry, dated 09-02-2016 of the Chief Secretariat, (Hr. \& Tech. Edn.) Puducherry]
d) Children of Defence Personnel who were killed or disabled in action and who have declared Puducherry as their hometown.

## II. Definition of Puducherry UT domicile categories:

(i) Puducherry UT - Unreserved (P-UR):

A candidate who is an Indian National satisfying the requirement of eligibility as prescribed by the NTA NEET 2021 Information Bulletin as well as Puducherry domicile criteria mentioned above (I) is eligible under this category.
(ii) Puducherry UT - Other Backward Classes - Non-Creamy layer (P-OBC-NCL): Applicants are required to ensure that he/she does not belong to the persons/ sections (Creamy Layer) mentioned in Column 3 of the Schedule to the Government of India, Department of Personnel \& Training O.M. No. 36012/22/93-Estt. (SCT) dated 08/09/93 which is modified vide OM No. 36033/3/2004 Estt. (Res.) dated 09/03/2004 or the latest notifications of the Government of India (i.e. Central list) in support of his/her claim.

OBC Certificate must be in the format as mentioned in the NTA NEET 2021 Information Bulletin. A candidate satisfying the afore-mentioned definition as well as Puducherry domicile criteria mentioned above (I) is eligible under this category.
(iii) Puducherry UT - Scheduled Caste (P-SC):

Applicants will be required to produce the necessary certificate in the format provided. During counselling the certificate as prescribed in M.H.A., O.M., No. 42/21/49-N.G.S. dated the 28.1.1952, as revised in Dept. of Per-\& A.R. letter No. 36012/6/76-Est. (S.CT), dated the 29.10.1977, to be produced by candidate belonging to a Scheduled Caste in support of his/her claim. SC/ST Certificate must be in the format as mentioned in the NTA NEET 2021 Information Bulletin. A candidate satisfying the afore-mentioned definition as well as Puducherry domicile criteria mentioned above (I) is eligible under this category.
(iv) Puducherry UT - Scheduled Tribe (P-ST):

Applicants will be required to produce the necessary certificate in the format provided. During counselling the certificate as prescribed in M.H.A., O.M., No. 42/21/49-N.G.S. dated the 28.1.1952, as revised in Dept. of Per-\& A.R. letter No. 36012/6/76-Est. (S.CT), dated the 29.10.1977, to be produced by candidate belonging to a Scheduled Tribe in support of his/her claim. SC/ST Certificate must be in the format as mentioned in the NTA NEET 2021 Information Bulletin. A candidate satisfying the afore-mentioned definition as well as Puducherry domicile criteria mentioned above (I) is eligible under this category.
(v) Puducherry UT - Economically Weaker Sections (P-EWSs):

Applicants who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs. 8.00 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.
Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:
i. 5 acres of agricultural land and above;
ii. Residential flat of 1000 sq. ft. and above;
iii. Residential plot of 100 sq. yards and above in notified municipalities;
iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
The property held by a "Family" in different locations or different places/ cities would be clubbed while applying the land or property holding test to determine EWS status. The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. (As per the Office Memorandum F.No.36039/1/2019 dated 31st January 2019 by Ministry of Personnel, Public Grievances \& Pension \& F.No. A11013/01/2019 dated 28th February 2019 by Ministry of Health \& Family Welfare, Government of India. A candidate satisfying the afore-mentioned definition as well as Puducherry domicile criteria mentioned above (I) is eligible under this category.
(vi) Puducherry UT - Persons with Benchmark Disability (P-PwBD):

The eligibility of candidates to pursue a course in medicine with specified benchmark disability shall be in accordance with NTA NEET 2021 Information Bulletin.
If any candidates submit the false information / forged certificates will be subjected to prosecution. If it is confirmed, their candidature will be cancelled.
A candidate satisfying the afore-mentioned definition as well as Puducherry domicile criteria mentioned above (I) is eligible under this category.
Any dispute in Residence/Community certificate of Puducherry issued by Authorised Personnel of Govt. of Puducherry should be referred to the Court of law. The same will not be dealt by this Institution.

## 1. The minimum NEET cut-off percentile (Category wise-UR/EWS/SC/ ST/OBC/PwD) for participating in the B.Sc. (N) Counselling process.

This is the first time that Common Entrance Examination (NEET) and Common Counseling is attempted for the admission to B.Sc. Nursing at the National level. Since online counselling process is to be conducted by MCC using the software prepared by NIC, it is suggested that the minimum NEET cut-off percentile for participating in the B.Sc. (N) Counselling process may also be the same as applicable to all other courses (MBBS/BDS) i.e. 50 percentile for UR, 40 percentile for $\mathrm{SC} / \mathrm{ST} / \mathrm{OBC}$ and 45 percentile for UR-PwD.
2. The State Quota eligibility conditions of the Nursing Institutes for 85\% State Quota seats.

The State quota eligibility conditions of the Nursing Institutes for 85\% State quota Seats is only for the NCT of Delhi.
