Therefore, the Candidates who are willing to participate in the said Round of Counselling may complete the admission formalities **by 15/02/2021** as per schedule.

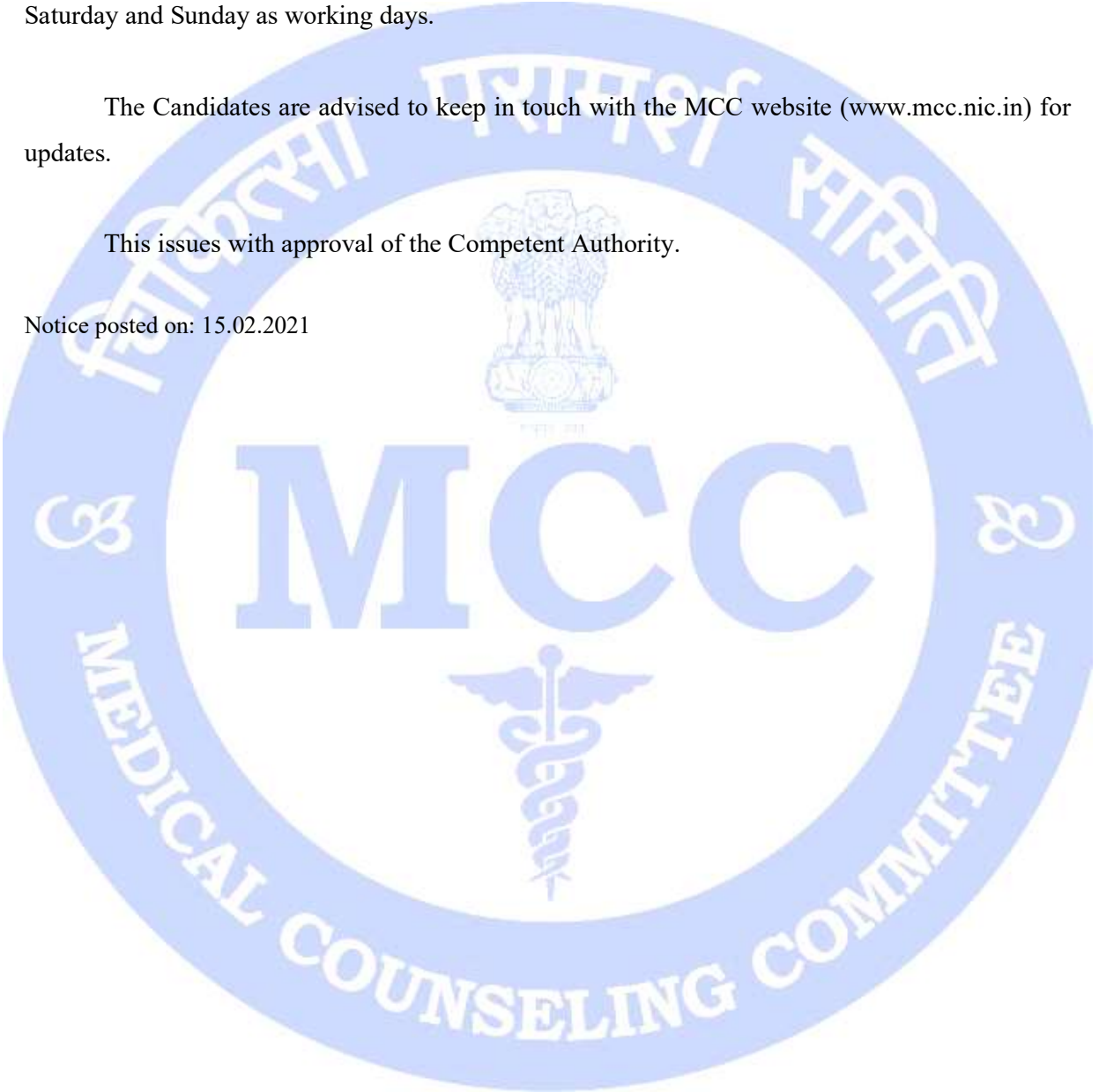
