Cancelling request of Rajarajeswari Medical College and Hospital, Bangalore (Karnataka) regarding inclusion of the college under the ambit of Dr. MGR Educational and Research Institute (Deemed to be University), Chennai, Tamilnadu.

1) Notification dated 14-02-2019 of Ministry of HRD, Department of Higher Education, ICR division, New Delhi.

2) Writ Petition No: 7482/2020 Order Dated 03/11/2020.

With reference to the above mentioned subject, University Grants Commission has sought comments of the State Government in respect of issuing No Objection Certificate for inclusion of Rajarajeswari Medical College and Hospital, Bangalore under the ambit of Dr. MGR Educational and Research Institute, Chennai (Deemed to Be University).

The State Government rejected the request of the college stating that any No Objection Certificate issued to the College would affect the students

of the state and would go against the interest of the State as the College has requested that he would run the college in the State as it would be helpful to the Tamil Linguistic Minority and other students of the State vide letter dated 14-01-2019.

Inspite of rejecting the request of the college the Rajarajeshwari Medical College and Hospital, Bangalore was given approval including Rajarajeswari Medical College and Hospital, Bangalore under the ambit of Dr. MGR Educational and Research Institute, Chennai (Deemed to Be University) vide Notification at ref (1) above. But the College even to this date is affiliated to Rajiv Gandhi University of Health Sciences and at no point of time the university has disaffiliated the College.

Rajiv Gandhi University of Health Sciences, Karnataka vide letter dated 05-08-2019 has informed the college that the College continues to the under the State University and will adhere to the policies issued by the State Government.

Rajiv Gandhi University of Health sciences, Karnataka issued a letter dated 29.02.2020 to the Vice Chancellor, Dr. MGR Educational and Research Institute, Chennai informing that The Union of India issued Notification dated 14.02.2019 with a condition that Dr. MGR Educational and Research Institute, Chennai, Tamil Nadu shall award degrees only to those students who are enrolled in Rajarajeshwari Medical College and Hospital after disaffiliation from the Rajiv Gandhi University of Health Sciences, Karnataka. As long as it is not disaffiliated by Rajiv Gandhi University of Health Sciences, Karnataka the Rajarajeshwari Medical College and Hospital College continues to be affiliated to the Rajiv Gandhi University of Health Sciences, University.

The syndicate of Rajiv Gandhi University of Health Sciences in its meeting held on 07.07.2019, 23.08.2019 and 05.02.2020 has rejected the claim of the Rajarajeshwari Medical College and Hospital for disaffiliation and it is specifically concluded in the meeting that any disaffiliation of Rajarajeshwari Medical College and Hospital from Rajiv Gandhi University of Health Sciences University would affect the Students of the State and goes

contrary to the Trust Deed wherein it had obtained the Essentiality Certificate and Feasibility Certificate only on the ground that it would run the College on Tamil Linguistic Minority status which would be helpful to the State Linguistic Minorities and other students of the State.

Aggreived by this decision, Moogambigai Charitable & Educational Trust, had file a Writ Petition in the Hon'ble High Court of Karnataka vide No. 7482/2020. Against this, petition, State Government had filed a Writ Petition No.9236/2020 questioning the Notification issued by the Central Government including Rajarajeswari Medical College and Hospital, Bangalore under the ambit of Dr. MGR Educational and Research Institute, Chennai (Deemed to Be University) vide ref (2) above.

After hearing, the petition, the court made the following order:

- (i) The case in W.P.No.7482/2020 filed by Moogambigai Charitable & Educational Trust, Bengaluru and two others, being devoid of merits is liable to be dismissed and accordingly it is; the companion case in W.P.No.9236/2020 filed by the State of Karnataka & another being meritorious, is entitled to be allowed and accordingly it is;
- (ii) A Writ of Certiorari issues quashing the impugned Inclusion Notification issued by the Central Government where by Raja Rajeswari Medical College & Hospital, Bengaluru was included in the ambit of Dr. MGR Educational & Research Institute, Chennai (a Deemed to be University), and consequently the said Inclusion stands undone;
- (iii) A Writ of Mandamus issues to the Central Government and the Medical Council of India, to take within eight weeks, all steps as are required for restoring the position of the parties i.e., college, State

Health University and Deemed to be University, inter se as before, subject to the rider that such steps or the restoration shall not affect the admission of students to the undergraduate & post-graduate medical courses hitherto done by Dr MGR educational and Research Institute, post impugned notification and, only to that limited extent, Regulations 13.03 & 13.12, shall be invokable.

Based on the above order of Hon'ble High Court of Karnataka, the State humbly requests you to not allot any further seats of Rajarajeswari Medical College and Hospital, Bangalore in the second round of counseling. Further if any student allotted in the first round is upgraded or surrenders the seats they may not be re allotted. all the seats so reverted shall be filled through the second round of state councils
