Sub : Notification of Schedule of Round-1 of NEET PG Counselling 2020 for States - reg.

Sir,

I would like to draw your kind attention to the Schedule of PG Counselling, 2020 with the stipulated Time frame work as per MCI Gazette Notification (enclosed as **ANNEXURE-I**). Accordingly, the Round-1 of All India Quota of PG Counselling was commenced on 12th March to be completed on 3rd April. However, the same had to be halted amid the Lock down imposed by the Govt. of India due to COVID 19 outbreak.

In the meeting held on 7th April, 2020 with MoHFW, it was decided by the competent authority to resume the counselling in view of number of representations being received from the participating institutes and the candidates for the same. Hence, the Round-1 of PG Counselling was resumed from 9th April followed by publication of result on 10th April, 2020. The Reporting module for Physical/ Online joining for Round-1 is already in progress since 13th April and the last date for the same is 24th April, 2020 (Copy of revised schedule enclosed as **ANNEXURE-II**)

Now, lot of requests and queries are being received from State Counselling authorities regarding their schedule for PG Counselling. This matter was taken up with the Ministry and Round-1 of State counselling from 20th April to 4th May, 2020 has been approved by them. The same may be notified if possible, to all State Counselling authorities and displayed on MCI website. Further, schedule of Round-2 of All India Quota and State counselling will be informed later as the Lock down is still continuing and physical movement of the students is not possible.

This issues with the approval of competent authority.

सं. भा. आ. प/18(1)/2017-मैडि./174626.—भारतीय आयुर्विज्ञान परिषद् अधिनियम, 1956 (1956 का 102) की धारा 33 द्वारा प्रदत्त शक्तियों का इस्तेमाल करते हुए भारतीय आयुर्विज्ञान परिषद्, "स्नातकोत्तर शिक्षा विनियमावली, 2000" को पुनः संशोधित करने के लिए केंद्र सरकार की पूर्व स्वीकृति से एतद्वारा निम्नलिखित नियम बनाती है, नामतः—

No. MCI-18(1)/2017-Med./174626.—In exercise of powers conferred by Section 33 of the Indian Medical Council Act, 1956 (102 of 1956), the Medical Council of India with the previous sanction of the Central Government hereby makes the following regulations to further amend the "Postgraduate Medical Education Regulations, 2000" namely:-

1. (i) These regulations may be called the "Postgraduate Medical Education (Amendment) Regulations, 2018."
- (ii) They shall come into force from the date of their publication in the Official Gazette.
2. In the "Postgraduate Medical Education Regulations, 2000", the following additions/modifications / deletions / substitutions, shall be as indicated therein:-
3. In the Appendix in "Postgraduate Medical Education Regulations, 2000", the time schedule for completion of admission process for postgraduate courses (Broad Speciality) stands substituted by the following :-
