## • POINTS TO BE NOTED:

➤ The Eligibility of candidates to participate in special mop-up round of Superspeciality is reiterated as under:

### a. ELIGIBLE CANDIDATES:

- Only Candidates who have not joined any seat in previous rounds of AIQ or are not holding any seats in Counselling conducted by State of Tamil Nadu (*in-service seats*) are eligible to participate.
- Candidates who have not registered in earlier rounds of AIQ may register & participate by paying fresh the security amount in Special mop-up round of SS Counselling 2021.

• Candidates who have registered in earlier rounds of AIQ or Counselling conducted by State of Tamil Nadu (*in-service seats*) but have not been allotted any seat.
