ADMISSION NOTICE: SUPERSPECIALITY COURSES AT AFMC, PUNE THROUGH CENTRAL COUNSELLING BY DGHS, MoHFW FOR THE YEAR 2019

- 1. Armed Forces Medical College (AFMC), Pune conducts Post-doctoral/Superspeciality training primarily for the doctors of Armed Forces Medical Services.
- 2. <u>Eligibility Criteria</u> The eligibility criteria for admission to superspecialty courses at AFMC Pune are:-

(a) **Categories**

- (i) <u>Serving officers of the AFMS</u>: AFMS officers granted study leave.
- (ii) <u>Medical Officers sponsored by Para Military Forces/other</u>
 <u>Govt of India organizations:</u> A Sponsorship Certificate as per **Appx**'A' issued by the sponsoring authority to the candidate, specific to the subject allotted, is a mandatory requirement for admission.

(ii) **EX-SSC AFMS officers**:

- Officers released from service after completion of contractual service, within three years after the release from service are eligible for admission with no service / bond liability. The date of release should not be before 01 Aug 2016 for the session starting from Aug 2019.
- Officers who have resigned the commission/dismissed/removed from service/ not completed the contractual service are **Not Eligible** under this category.
- AFMS officers with date of release from service prior to 01 Aug 2016 will have service/bond liability as applicable to civilian doctors.

(iv) Civilian doctors:

- The candidate should be willing to serve the Armed Forces Medical Services (AFMS) for 05 years subject to fulfilling other eligibility criteria. Candidate will have to execute a bond agreement to pay as per **Appx 'B'** at the time of admission, to pay a sum of Rs. Thirty Five Lacs (Rs. 35,00,000/-) to Govt of India, in case unwilling to join AFMS when offered commission on completion of the course. Maximum permissible age shall be 40 yrs as on 01 Aug 2019.
- Civilian doctors will have to undergo medical examination by a duly constituted medical board at the time of admission, so as to assess their fitness for commissioning as per laid down criteria and will be admitted only if found fit.

<u>Authority</u>: GoI letter No. F/PC-8510/DGAFMS/DG-1D/345/2013/D(Med) dated 6th March 2013 and GoI letter No. PC III/17436/DGAFMS/DG-1D/1819/13(a)/D (Med) dated 15 January 2014.

- (b) **Qualifications:** Candidate must have MBBS & MD/MS/DNB Degree registered with State Medical Council or MCI. Students who have completed / are competing Postgraduation by 31 Jul 2019 are eligible for admission alongwith Provisional Registration Certificate.
- (c) The candidate must be a citizen of India.
- (d) A candidate who is already pursuing any Superspeciality course, shall not be eligible for admission to another Surperspeciality course in the Academic year 2019-20.
- 3. **SEATS & RECOGNITION STATUS**: AFMC, Pune is recognized by the Medical Council of India (MCI) and is affiliated to Maharashtra University of Health Sciences, Nashik for the following Superspeciality courses:—

(a) DM (Cardiology) : 01
(b) MCh (CTVS Surgery) : 03
(c) MCh (Neurosurgery) : 03
(d) MCh (Plastic Surgery) : 03

4. **COUNSELLING**: As per the Govt of India, Ministry of Health & Family Welfare letter No. V.26012/02/2016 MEP (Pt) dated 04 May 2017, there shall be a common counselling for all seats of NEET Superspecility at national level to be conducted by Directorate General of Health Services (DGHS). Hence, all eligible candidates desirous of admission to Post-doctoral courses (DM/MCh) at AFMC, Pune for the session commencing from Aug 2019 will have to register on portal for Superspeciality courses on the MCC website: **www.mcc.nic.in**.

5. PROCESS OF ADMISSION AND MEDICAL EXAMINATION

The following process will be adopted by candidates:-

- (a) All candidates seeking admission should register on the portal for Supespeciality courses on website: www.mcc.nic.in. It is the responsibility of the candidate to ascertain whether they meet the requisite eligibility criteria.
- (b) Candidates while reporting for admission, will have to bring the following documents:-
 - (i) 06 (Six) Passport size latest photographs.
 - (ii) Copy of the NEET-SS 2019 Admit card.
 - (iii) NEET-SS 2019 Score Card.
 - (iv) Copy of Class X/SSLC/ICSE certificate as valid certificate of proof of age.
 - (v) Copy of University Mark Sheet of first to final MBBS examinations and Postgraduation course.
 - (vi) Copy of Internship Completion Certificate.

- (vii) Copy of Permanent / Provisional State Medical Council Registration Certificate of MBBS & Postgraduation course
- (viii) Copy of MBBS & Postgraduation degree (Passing Certificate, if degree has not been received).
- (ix) Copy of Nationality Certificate/Xerox copy of valid Passport/Domicile Certificate/Birth Certificate.
- (x) Copy of Attempt Certificate (MBBS & MD/MS/DNB as applicable).
- (xi) Copy of Transfer Certificate for non-AFMC Candidate.
- (xii) Copy of Migration Certificate for Non-MUHS Candidate.
- (xiii) Copy of Aadhaar Card.
- (xiv) Sponsorship Certificate in case of Medical Officers sponsored by Para-Military Forces/Govt of India organizations. Sponsorship Certificate issued by the sponsoring authority should be specific to the subject allotted to the candidate only and is a mandatory requirement for the candidate to be considered for admission.
- (xv) In case of Ex-AFMS/SSC Officers, release order from Armed Forces Medical Services by DGAFMS/concerned Medical Directorate. (xvi) Civilian candidates, if selected, will be required to execute a bond agreement to serve as Short Service Commission (SSC) officer for 5 years with the Armed Forces Medical Services (Service liability) or pay an amount of Rs. 35 lacs (Rupees Thirty Five lacs only) to Govt of India if unwilling to join on successful completion of the course and subject to being offered the said commission as per GoI letter No: PCIII/17436/DGAFMS/DG1D/1819/13/(a)/D (Medical) dated 15 January 2014.

<u>Note:</u> Admission to DM/MCh courses at AFMC, Pune is provisional subject to confirmation/ratification by the office of DGAFMS, MUHS Nashik & MCI. Candidates are free to seek any clarification at the time of counseling/admission.

6. <u>ANTEDATE SENIORITY FOR CIVILIAN DOCTORS COMMISSIONED IN</u> **AFMS**

The civilian doctors, on grant of commission in the Armed Forces, will be eligible to apply for ante date serniority within 01 year of grant of Short Service Commission, in accordance with GoI letter No. 3569/DGAFMS/DG1b(i)/3394/D (Med) dated 20th Dec 2011 as under –

- (a) **PG DEGREE** 36 months (For NBE/MCI recognized PG degree obtained from a recognized institution after a PG Degree course of 03 years duration).
- (b) **PG DIPLOMA** 24 months (For NBE/MCI recognized PG Diploma obtained from a recognized institution after a PG Diploma course of 02 years duration).
- (c) Maximum antedate seniority in case of a candidate eligible for antedate under more than one counts as givien in AI 74/76 & 75/78 read with paras 6 (a) & (b) above, will be limited to a total period of 42 months (DGAFMS is the final authority regarding grant of antedate seniority to any officer).

- (b) That in the event of the Post Doctoral Student refusing to accept commission in the Armed Forces Medical Services on successful completion of his/her Post Doctoral degree course, the Post Doctoral Student and the Surety shall jointly be liable to pay and refund forthwith to the Government of India on demand and without demur in cash an amount of Rupees Thirty Five Lakhs as per Gol Letter No: PCIII/17436/DGAFMS/DG-1D/1819/13/(a)/D (Medical) dated 15 January 2014.
- (c) That the Post Doctoral Student shall on successful completion of his / her Post Doctoral degree Course will report within such period, as may be allowed by the Director General Armed Forces Medical Services as joining time to the unit or station as specified in this behalf by the Director General Armed Forces Medical Services for grant of short Service Commission on terms and conditions set out in Army Instructions 75/78 and as amended time to time.
- (d) That if the Post Doctoral Student after grant of short service commission applies for release from service within Five years of grant of said commission for any reason whatsoever and provided his / her release is sanctioned by the Govt, as per the rules inforce, he / she shall be relieved only after he / she has refunded bond money at the rate of Rupees **Seven Lakhs** per completed year or part thereof of unfulfilled liability to the bond money as contained in the bond agreement executed at the time of admission.

- (e) That if the Post Doctoral student leaves the Post Doctoral institution without completing the course due to any reason after the last date of admission to the Post Doctoral course as specified by MCI / affiliated University, he/she will be required to pay a sum of Rupees **Seven Lakhs** per year or part there-of of the education at the institution based on extant rules
- (f) That the Post Doctoral Student made Non Service Liability (NSL) on medical grounds will be required to pay bond money at 50% of amount laid down, before he/she is allowed to continue his/her studies. However, in case of students becoming medically unfit for commission due to any disease or disability contracted in the circumstances over which he/she has no control (on which the decision of DGAFMS shall be final) and for which he/she has not refused treatment, he/she will not be required to pay any Bond money but will have to pay the cost of training as applicable for further period of study from the date declared NSL.
- (g) That the Post Doctoral student leaves the institution and refuses to fulfill any of bond conditions, his original documents will not be handed over until he pays the surety bond money as decided by the Comdt of the AFMS Post Doctoral institution.
- (h) Amendments to the rules / procedures for admission may be carried out as per regulations laid down by the Govt of India/ MCI /DGAFMS / University from time to time and candidate will have to abide by such rules/ regulations/ policy.
- (i) <u>Arbitration Clause</u>. Any dispute arising out of or in connection with this surety bond, including any question regarding its existence, validity or discharge, shall be referred to and finally resolved by arbitration under the India Arbitration Rules/ Act. Arbitrator will be decided by the DGAFMS, however fees of the Arbitrator will be paid equally by both the parties.
