In continuation to earlier Notice dated 09.12.2023 wherein resignation was allowed to SS candidates allotted seats through 1<sup>st</sup> Round seat allocation of **INI-SS Entrance Examination conducted by AIIMS.** In this regard, please find attached the Second list of candidates who have been allowed to **Resign/ Not Report** on seats allotted to them in Round-1 of All India SS Counselling 2023 without forfeiture of Security Deposit.

Candidates who have reported on their allotted seats (as per attached list) can now take their original certificates back from the allotted college.
