The portal shall remain open from 05.07.2025 till 09.07.2025 upto 5:00 p.m.

In case, the documents uplouded by the applicant at the time of registration does not support the claimed Privatey in the ECC then the applicant will be declared as 'Not Effgible'.

(ii) The applicant for admission to UO Courses (MRDS/BDS) under CW Category will be required to upload all the relevant documents in prescribed format and also which is in legible form at

the time of submission of their application. Further, the applicant will not be allowed for addition any new document after final submission of their application on the CW Partal and there would be no further communication allowed in any case. No Change or additional documents will be accepted after the documents have been uploaded on the online CW portal.

- (iii) The consolidated list of the registered candidates on the CW portal for entitlement under Delhi Quota (85%) shall be verified by the MCAC (UG) for their eligibility as per norms of the University of Delhi. The list of the candidates eligible for Delhi Quota (85%) shall be provided to the KSB, PMA Cell, MHA (for priority V (vil & x) and WARB, MHA (for the remaining Priorities Priority I to V only) alongwith the application forms and relevant documents for verification, as the case may be. The candidates who will not fulfill the eligibility enterna for Delhi Quota (85%) shall be excluded from the list with the remark "Outside Delhi candidate".
- (iv) The authorities of KSB, PMA Cell, and WARB, MHA will be responsible for addressing any grievances or litigations arising from the verification of CW/ECC certificates submitted by candidates through University of Delhi. The University of Delhi will not be held responsible for such issues.
- (v) The Issuing authority is responsible for the issuance of this certificate in accordance with the governing laws and regulations of the Ministry of Defence / Ministry of Home Affairs, as applicable.
- (vi) In the event of any issue/claim/dispute before the court of law in the matter of Priority assigned, the issuing authority shall defend the case, in the court of law and the University of Delhi shall be indemnified for such issue/claim/dispute.
- (vii) The provisional list of the eligible candidates for their entitlement under CW Category (Deibi Ouota) duly verified by the KSB/MHA shall be forwarded to the MCC before the commencement of the 1st Round of councelling to conduct the counselling and to allot the seat on the basis of All India Rank, Category and Priority of the respective candidates for provisional admission subject to verification of the original documents by the concerned college at the time of reporting for admission by the selected candidate.
