Urgent Attention Candidates:

In reference to the requests being received by MCC from Super Specialty candidates, the competent authority has allowed resignation for candidates who have joined seats in Round-1 & Round-2 of SS Counselling 2024 but now want to leave their seat. Such candidates should make note of following points:

- The INI allotted candidates can resign from their seats upto 05:00 P.M of 15.07.2025. The resignation for INI candidates will be Without forfeiture of security deposit. However, once resigned the INI allotted candidates will not be able to participate in further rounds of SS Counselling 2024. INI allotted candidates who want to RESIGN their Round-1 or Round-2 seat allotted through MCC should send their INI-SS RANK LETTER along with following undertaking (Copy attached) to MCC on email id: colleges.superspeciality@gmail.com_from 10:00 AM of 12.07.2025 upto 12:00 Noon of 14.07.2025. Candidates who send mails along with required documents will only be allowed to RESIGN from their JOINED SEAT. However, such candidates will not be eligible to participate in further round of SS Counselling 2024 to be conducted by MCC.
- Candidates who have been allotted seats in Round-1 and Round-2 of SS Counselling 2024 can resign from their respective seats With Forfeiture of Security Deposit. However, once resigned such candidates will not be able to participate in further round of SS Counselling 2024.
- It is noteworthy that Stray Round of SS Counselling 2024 will be an upgradation round. Candidates of Round-1 & Round-2 joined so far can upgrade themselves in Stray Round. Hence, candidates are advised to take an informed decision whether they want to resign from their Round-1 or Round-2 seat or want to upgrade.
- However, there will be No Resignation in Stray Round of SS Counselling 2024. If a candidate is not upgraded and the earlier seat is retained, then the candidate will have to continue studying on the retained seat.

- The resignation facility will be provided till 05:00 P.M of 15.07.2025 with forfeiture of security deposit for Round 1 & Round 2 joined candidates.
- The above-mentioned candidates who wish to resign from their seat may approach their allotted college to resign and collect their original documents within stipulated time. It should be ensured by the candidates that the resignation letter is generated 'Online' from the MCC portal by the college authorities. Any offline resignation taken by the college will be treated as 'Null & Void'.
