Sub: Allocation of foodgrains to Maharashtra under National Food Security Act, 2013 from February, 2014 onwards – reg.

Sir,

I am directed to refer to your letter No. ASUKA-2013/CR-376/CS-22 dated 18.1.2014 on the above subject and to say that it has been decided to allot a monthly quantity of 164636 tons of rice and 210497 tons of wheat to Maharashtra under NFSA at Central Issue Prices of Rs. 3.00 per kg for rice and Rs.2.00 per kg for wheat from February, 2014 onwards.

2. The validity period for deposit of cost and lifting of February, 2014 allocation will be 50 days from the date of issue of this letter. The validity period for deposit of cost and lifting of allocation for the month of March 2014 onwards will be as per the existing guidelines. In case any quantity of February 2014 allocation under the existing TPDS allocation has been lifted in excess of the above allocation under NFSA, the same may be adjusted against the allocation made under NFSA for the subsequent months. Resultant differential cost, if any, may be adjusted with FCI in future billing of the State.

3. The above allocation of foodgrains under NFSA will supersede this Department's earlier allocation issued vide letters no.1-1/2013-BP.III (16) dated 26.2.2013 and 25.3.2013 regarding normal AAY, BPL and APL allocation under TPDS for the year 2013-14, letter no. 1-2/2013-BP.III dated 22.5.2013 regarding additional APL allocation under TPDS for the year 2013-14 and letter no.1-3/2013-BP.III dated 19.9.2013 regarding additional BPL allocation. The other terms and conditions mentioned in the letters dated 26.2.2013, 25.3.2013 and 22.5.2013 referred to above will remain unchanged.
