I am directed to refer to your DO No.Adhapu-2011/-149/CS-22 dated 2.8.2012 and this Department's letter No. 1-1/2012-BP-III(16) dated 12.03.2012 on the above subject and to say that it has been decided to increase the monthly APL rice allocation by corresponding reduction in the quantity of wheat to Maharashtra. Accordingly, in partial modification to this Department's annual allocation letter No. 1-1/2012-BP-III(16) dated 12.03.2012, the revised monthly allocation of foodgrains to Maharashtra under TPDS, with effect from December, 2012 to March 2013 will be as follows:
