Subject: Increase proportion of rice in APL allocation to Maharashtra under TPDS.

Sir,

I am directed to refer to your DO No.Adhapu-2011/-149/CS-22 dated 2.8.2012 and this Department's letter No. 1-1/2012-BP-III(16) dated 12.03.2012 on the above subject and to say that it has been decided to increase the monthly APL rice allocation by corresponding reduction in the quantity of wheat to Maharashtra. Accordingly, in partial modification to this Department's annual allocation letter No. 1-1/2012-BP-III(16) dated 12.03.2012, the revised monthly allocation of foodgrains to Maharashtra under TPDS, with effect from December, 2012 to March 2013 will be as follows:

2. The validity period for depositing the cost and lifting of revised allocation of foodgrains for December 2012 and January 2013 will be 50 days from the date of issue of this letter. For rest of the months, it will be same as applicable under normal monthly TPDS allocations. In case the December, 2012 allocation has already been lifted, suitable adjustments may be made in the subsequent months as per above revised allocation.

3. All other terms and conditions as mentioned in the allocation order No. 1-1/2012-BP-III(16) dated 12.03.2012 will remain same.
