पेट्रोलियम और प्राकृतिक गैस मंत्रालय के उनके दिनांक 14 दिसम्बर, 2015 के पत्र संख्या पी-21016/08/2015-वितरण (एफटीएस सं. 37327) द्वारा किए गए तिमाही आबंटन के आधार पर, 2015-16 (जनवरी-मार्च, 2016) की चौथी तिमाही के लिए पी.डी.एस. केरोसीन का राज्यवार/तेल कंपनीवार आबंटन अनुबंध में दिया गया है । कृपया ध्यान दें कि आबंटन किलो लीटर में किया गया है ।

2 इस संबंध में, कृपया निम्नलिखित का ध्यान रखें और अनुपालन सुनिश्चित करें:

(क) जहां तक संभव हो सका, हमने कंपनीवार आबंटन 12 किलो लीटर के गुणक में पूर्ण किया है ताकि बिना किसी चूक के पूरी मात्रा उठाने हेतु तेल विपणन कंपनियां समर्थ हो सकें । आबंटन की पूरी मात्रा उठाने में आने वाली समस्या से बचने के लिए 12 किलो लीटर गुणक में जिलावार आबंटन रखने के लिए भी यह वांछनीय होगा ।

(ख) राज्य सरकारों / केन्द्र शासित प्रदेशों के प्रशासनों से अनुरोध है कि वे मंत्रालय द्वारा सूचित उठाव (अपलिफ्टमेंट) अनुसूची के अनुसार उनके द्वारा तय किए गए उसी माह के दौरान ही मासिक आबंटन की पूरी मात्रा को उठाना सुनिश्चित करें । उठाई न गई मात्रा को बाद में अगले महीनों में उठाने की, यदि कोई हो, प्राकृतिक आपदाओं जैसी तात्कालिक आवश्यकता के मामले को छोड़कर, अनुमति नहीं दी जाएगी ।

Subject: Company-wise / State-wise SKO allocation for distribution under
Public Distribution System for the Fourth Quarter of 2015-16
(January-March 2016)

Based on the quarterly allocation made by MoP&NG vide its letter No. P-21016/08/2015-Dist. dated 14th December, 2015, State-wise/ Oil company-wise allocation of PDS SKO for the fourth Quarter of 2015-16 (January-March 2016) is given in **Annexure**. Please note that the Allocation is made in **KLs**.

- 2 In this regard, please note the following and ensure compliance:
- a) As far as possible, we have rounded the company-wise allocation to multiple of 12 KL to enable OMCs to uplift the entire quantity without any lapses. It would be desirable to keep district-wise allocation also in multiple of 12 KL to avoid problem in uplifting full quantity of allocation.
 - b) State Governments/UT administrations are requested to ensure lifting of the entire monthly allocation decided by them during that month itself as per the upliftment schedule advised by the Ministry. No carry forward of the un-lifted quantity, if any, to subsequent month(s) would be allowed, except in the case of exigencies such as natural calamities.

- c) State Governments/UT administrations are further requested to ensure that availability of subsidized Kerosene is for distribution under Public Distribution System to the targeted beneficiaries, only for the purposes of cooking and illumination. They are also requested to ensure that the subsidized Kerosene is not diverted for adulteration of Petrol/Diesel or for any other use.


