- 2. The validity period for depositing of cost and lifting of the food grains for the months of **April & July**, 2013 will be 45 days and 50 days respectively from the date of issue of this letter. For the remaining months, the validity period for deposit of cost and lifting of food grains will be as per extant guidelines dated 18.7.2008.
- 3. The food grains allocated under Annapurna Scheme should be utilized only for the purpose for which the same have been allocated and not for any other purpose/scheme. The monitoring and implementation of the distribution of subsidized food grains under the programme will be the responsibility of the concerned State Government. The food grains under the scheme must be distributed by the State Governments through Fair Price shops.
- 4. FCI will issue rice/wheat to the nominees of the State Governments as per district-wise sub allocation to be made by the State Governments on pre-payment of the cost of food grains at BPL price from its nearest godowns/depots.
- 5. FCI may accordingly give suitable instructions to its concerned Regional Offices under intimation to this Department.

6. Allocation for the balance period of the current year 2013-14 i.e. from October, 2013 to March, 2014 will be considered only on receipt of proper Utilization Certificate of 2012-13 from the States/UTs under the scheme, if any.
