महोदय,

राष्ट्रीय वित्तीय रिपोर्टिंग प्राधिकरण (एन.एफ.आर.ए.), नई दिल्ली, कंपनी अधिनियम, 2013 की धारा 132 के तहत स्थापित एक सांविधिक निकाय है। एन.एफ.आर.ए. की स्थापना, लेखांकन और लेखापरीक्षा के उच्च गुणवत्ता मानकों को स्थापित करते हुए तथा कंपनियों और निगमित निकायों द्वारा निष्पादित लेखांकन कार्यों और लेखापरीक्षकों द्वारा किए गए लेखापरीक्षा कार्यों की प्रभावी निगरानी करते हुए, सार्वजनिक हित और निवेशकों, लेनदारों और कंपनियों या निकायों से जुड़े अन्य लोगों के हितों की रक्षा करने के लिए की गई है।

2. प्राधिकरण ने कारपोरेट कार्य मंत्रालय का असाधारण राजपत्र संख्या 369 दिनांक 16.5.19 के द्वारा अधिसूचित भर्ती नियमों और मंत्रालय पत्र संख्या एनएफआरए-05/14/2020-कंप-एमसीए दिनांक 18.8.2020 के अनुसार, अपने मुख्यालय नई दिल्ली में **अनुलग्नक-1** में दिए गए पदों को भरने का कार्य निम्नलिखित रूप से प्रस्तुत किया है। (उपयुक्त प्रतियां एनएफआरए की वेबसाइट "अधिसूचना" सीधी भर्ती" पर उपलब्ध हैं):

ए.सी.आर./ए.पी.ए.आर. की प्रमाणित प्रतियों के साथ निर्धारित प्रोफार्मा (अनुलग्नक-II) में आवेदन अग्रेषित कृपया करें। यह भी सूचित किया जाता है कि एन.एफ.आर.ए. रिक्ति परिपत्र संख्या NF-12035/3/2021 दिनांक 02.12.2021 के विरुद्ध सहायक महाप्रबंधक के पद के लिए प्रस्तुत किए गए आवेदनों पर विचार नहीं किया जाएगा और इसलिए जिन उम्मीदवारों ने उक्त परिपत्र के विरुद्ध आवेदन किया है, वे इस परिपत्र के अनुसार नया आवेदन प्रस्तुत करें।
