

Shri Sushil Kumar Jaiswal, Full Time Member, NFRA

Shri Sushil Kumar Jaiswal is an officer of 1993 Batch of Indian Audit and Accounts Service (IA&AS). On appointment by the Appointment Committee of Cabinet as a Full Time Member, National Financial Reporting Authority (NFRA), he joined this organisation on 23 July 2025.

Shri Jaiswal holds a Bachelor of Commerce from Allahabad University, Master of Business Laws from NLSIU, Bangalore, Chartered Accountant from the Institute of Chartered Accountants of India, Company Secretary (Final- 1st Group) from the Institute of Company Secretaries of India, Certified Internal Auditor (CIA) from the IIA-USA, Certified Fraud Examiner (CFE) from ACFE-USA, Certified Information Systems Auditor (CISA) from ISACA-USA and a certification course on Cyber Laws from Indian Law Institute, New Delhi.

Shri Jaiswal has a distinguished career in public auditing and financial oversight. He has served the Government of India for over three decades (1993-2024), holding key positions across the offices of Comptroller and Auditor General of India (CAG). In his last three postings in CAG organisation, he served as (i) Director General of Audit (Central Receipt), New Delhi, responsible for CAG audit over all the offices/assessment offices under Department of Revenue, Govt. of India in three provinces including Delhi; (ii) the Accountant General (Audit), Delhi State, responsible for audit of all expenditure and revenue of Delhi Govt. including schemes and programmes in social and economic sector and agencies and State PSUs; and (iii) Principal Director of Commercial Audit and ex-officio Member, Audit Board, responsible for audit of Central PSUs like SAIL, MECON, National Highways. In between, he worked on a foreign posting for 5 years in Internal Audit Division of United Nations Peacekeeping Operations in UNOCI, Ivory Coast, West-Africa and UNAMI, Kuwait and Baghdad (2007-2012).

Besides, as a nominee of the CAG, he supervised external audits of United Nations Agencies and Funds and Programme namely, WFP, UNOPS, FAO, ITC and UNCC. He attended international training programmes at National Audit Office of UK, London, National Audit Office of Philippines, Manila and National University of Singapore.

Prior to joining the IA&AS, he served with a CA firm for about two years (1987-1988) and as Assistant Administration Officer (CA-Specialist) for 4 ½ years (1989-1993) at Chandigarh Regional Office of National Insurance Company Limited, a CPSU.
