## NFRA Chairperson emphasises the pivotal role of Accountancy in safeguarding public interest and building trust in financial reporting



A Panel Discussion was chaired by Ms. Smita Jhingran, Full Time Member, NFRA, on NFRA's Regulatory Approach: Building Better Audit Professionals, with Prof Sanjay Kallapur, Part Time Member, NFRA and CA J Venkateswarlu, Former CCM, ICAI, as panellists.

Apart from NFRA officers, speakers included eminent professionals such as CA MP Vijaykumar, Member, IFRS Interpretation Committee, CA P.R. Ramesh, Independent Director and CA Mohan Lavi, Partner, K.P. Rao & Co., amongst others. The event saw participation from members of the Hyderabad Chartered Accountants Society and several other professionals.

The technical sessions were designed to provide practical insights for practitioners and included important topics such as Audit Strategy Documentation, Sampling, and Audit Reporting.

Eminent expert speakers in the programme shared their professional experience and insights. They emphasised the profession's need to adapt to technology-driven audits, complex risk environments, and global opportunities.

NFRA reiterated its commitment to working closely with the Audit profession to uphold integrity, transparency, and accountability in financial reporting.
