Subject: Regarding Third Round of Counselling

In partial modification of clause No. 5.2.3 under heading "Third Round of Counselling" contained in the Information Brochure of JAC Delhi-2022 (page No. 71) may be read as follows.

#### 5.2.3 Third Round of Counselling

## <u>The following candidates are eligible for Round-3 of</u> Counselling:

- a) Any candidate who had not registered during previous round of counselling. Such candidate will have to first register on JAC Delhi portal. It may be noted that fresh registrations will only be opened for Round 3. There will be no fresh registrations in Rounds 2 and 4.
- b) The registered candidates who have not been offered any seat.
- c) The registered candidates who have not filled any choice during online registration process.
- d) The registered candidates who were allotted seat in some round of counselling, but the seat was cancelled due to some deficiency (or any other legitimate reason).
- e) The admitted candidates of rounds 1, 2 of counselling, who paid prescribed admission fee as required, also got their documents verified successfully and didn't freeze their seat (such candidates are eligible for institute/branch upgradation only).

### Procedure for participation in Round 3

Type I Candidates (those who do not hold any seat in any of the participating institute)

The eligible candidates (except candidates falling under clause e of

Section 5.2.3 above, have to follow the steps given below, in order to participate in Round 3.

- i. Any candidate who had not registered during previous rounds of counselling are required to first register on JAC Delhi portal and upload all required documents and pay registration fee of Rs. 1500/- and also fill their choices of branch & institute (Refer steps mentioned in Section 4.1 to 4.3).
  - *ii.* Previously registered candidates will be allowed to modify their choices as per the timelines specified in the counselling schedule on JAC Website.

# Type II (those who <u>already hold</u> a seat in any of the participating institute)

All admitted candidates as per the above-mentioned eligible candidates under clause e of Section 5.2.3, who have not freezed their allotted branch in the previous round, shall only be allowed to change their **preference of choices**. In order to change his/her choices, a candidate MUST visit JAC Delhi website and change his/her preferences using the candidate login as per counselling schedule.

#### Seat Allotment Procedure

a) Candidates of Type – I, who are allotted a seat in this round will have to pay the admission fee (refer Chapter 6 for details) as per the counselling schedule (available on the website jacdelhi.admissions.nic.in).

For a candidate failing to pay the admission fee as per the counselling schedule, his/her allotted seat will stand automatically cancelled and the candidate will not be considered for seat allotment in round 4.

Candidates of Type - II may either be allotted a seat of **higher** preference choice or their previously allotted seat will remain unchanged. They can, if they wish, freeze their allotted seat or wait for upgradation in round 4.



b) In case, a candidate, who has been admitted/upgraded in this round, desires to continue in the seat allotted (i.e. he/she does not want to be considered for upgradation to his/her higher preferences in subsequent rounds of counselling), then he/she must exercise the Branch Freezing option available in 'candidate login' on JAC Websiteon the day(s) mentioned in counselling schedule (after confirmation of admission).
